ORDER OF THE SECRETARY OF STATE, DATED AUGUST 28, 1934, UNDER SECTION 41 (2) OF THE ADMINISTRATION OF JUSTICE (SCOTLAND) ACT, 1933, (23 & 24 GEO. 5, c. 41).
