THE MERCHANDISE MARKS (IM-PORTED GOODS) EXEMPTION DIREC-TION (No. 5), 1934, DATED NOVEMBER 28, 1934, MADE BY THE BOARD OF TRADE UNDER SECTION 3 (1) OF THE MERCHANDISE MARKS ACT, 1926 (16 & 17 Geo. 5, c. 53).

Whereas by Section 3 subsection (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. 5, c. 53), it is provided that if, where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused, or is likely to cause, injury or hardship to the said persons or any of them, the Department may direct that the Order, or any particular provisions of the Order, shall cease to apply to goods of that class or description or shall apply to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while the Direction is in force, have effect subject thereto:

And whereas by Article 1 of the Merchandise Marks (Imported Goods) No. 10 Order, 1934, (a) it is (amongst other things) provided that it shall not be lawful to sell or expose for sale in the United Kingdom any imported goods of the descriptions specified in Class III. of the Schedule to that Order unless they bear an indication of origin:

And whereas sacks and bags made wholly or mainly of woven piece goods wholly or partly of jute whether or not coated, impregnated, or in any other way treated or operated upon are included in the descriptions of goods specified in Class III. of the Schedule to the said Order:

And whereas by Article 6 of the said Order it is (amongst other things) provided that the said Order shall come into force so far as regards goods specified in Class III. of the Schedule thereof on the 1st March 1935:

And whereas the Board of Trade, being the appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter, are satisfied that the application of the aforesaid provisions of Article 1 of the said Order to sacks and bags of the aforesaid descriptions prior to the first day of April 1935, is likely to cause hardship to the said persons:

Now therefore the Board of Trade in pursuance of the powers conferred upon them by the said Section 3 hereby direct as follows:—

- 1. Until the first day of April 1935, Article 1 of the Merchandise Marks (Imported Goods) No. 10 Order, 1934, shall not apply to imported sacks and bags made wholly or mainly of woven piece goods wholly or partly of jute whether or not coated, impregnated or in any other way treated or operated upon.
- 2. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction (No. 5) 1934.

REGULATIONS RESPECTING TWO SPECIAL QUALIFYING EXAMINATIONS FOR THE SITUATIONS OF TYPIST AND CLERK-TYPIST IN DEPARTMENTS OF THE CIVIL SERVICE.

1. Candidates must have been serving in a British Government Department on or before the 24th August 1932, and also on the 1st August 1934, in one of the following capacities, viz.:—Temporary Typist; Temporary Clerk-Typist; Temporary Shorthand-Typist; Temporary Clerk-Shorthand-Typist; Temporary Duplicator Operator in His Majesty's Stationery Office.

2. There will be no age limits for admission to these examinations, but candidates will not be eligible for appointment in an established capacity on the result of the first examination if they are over 50 years of age on the 1st August 1934, or on the result of the second examination if they are over 50 years of age on the 1st October 1935.

3. Candidates must be unmarried or widows, and before they can be appointed in an established capacity they will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.

4. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject.

Provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

5. Persons upon whose training for the

5. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

6. The Examination will be in the following subjects, viz.:—

1. English.

2. Arithmetic.

3. Typewriting.

No candidate will be regarded as qualified who does not pass to the satisfaction of the Civil Service Commissioners in English and in Typewriting.

7. Successful candidates will normally be assigned to the Departments in which they are serving. Transfer to another Department may in some cases become necessary, and in such cases it will rest with the Civil Service Commissioners to determine the Departments to which the candidates shall be assigned.

8. Application for permission to attend the Examinations must be made on each occasion at such times and in such manner as may be fixed by the Civil Service Commissioners; the application must be accompanied by a certificate from the authorities of the Department in which the candidate is serving, in the space provided on the application form, that she satisfies the conditions laid down in Clause 1 of these regulations and that her service has been approved.

9. No fee will be payable by candidates on admission to an examination held under these regulations; but a fee of five shillings will be payable by every candidate for establishment on the result of such examination before a certificate of qualification is issued in her favour.
