THE COUNTY COUNCIL OF PEEBLES-SHIRE ROADS (RESTRICTION) ORDER, 1934.

THE County Council of Peeblesshire, in exercise of the powers conferred on them under or by virtue of sub-section (1) of Section 46 of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933, hereby make the following Order:—

(1) Save as hereinafter provided, no person shall drive or cause to be driven any heavy locomotive, light locomotive, motor tractor, or heavy motor-car, or any motor-car with seats for more than seven persons exclusive of the driver, on the road specified in the Schedule hereto.

Nothing in this Order contained shall prevent the driving upon the said road of any vehicle which is being used:—

1. For the purposes of agriculture in connection with land adjoining or lying near to the said road or for the conveyance or haulage of timber felled upon such land; or

2. In connection with the maintenance, improvement, or reconstruction of the said road, or of any telegraph or telephone wires, cables, posts, or supports.

3. The Interpretation Act, 1889, applies for the purpose of the interpretation of this Order as it applies for the purpose of the interpretation of an Act of Parliament.

4. This Order may be cited as the Sware Road (Restriction) Order, 1934.
