HIS Majesty in Council was this day pleased to declare that having again been stricken by illness He was unable for the time being to give due attention to the affairs of the Realm, whereupon the Draft of a Commission making provision for the summoning and holding of the Privy Council and for the transaction of other matters and things on behalf of His Majesty, more particularly specified in the Schedule annexed thereto, was this day read at the Board and approved; and His Majesty was further pleased to nominate Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.M.M.G., G.C.I.E., G.C.V.O., G.M.B.E., His Royal Highness the Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.C.M.G., G.C.V.O., and His Royal K.P., G.C.M.G., G.C.V.O., and His Royal Highness The Duke of Kent, K.G., K.T., G.C.M.G., G.C.V.O., for the purposes therein mentioned and to declare that they should be designated under the style and title of Counsellors of State.

His Majesty was also pleased by and with the advice of His Privy Council to order, and it is hereby ordered, that the Right Honourable Sir John Simon, one of His Majesty's Principal Secretaries of State, do cause a Warrant to be prepared, for His Majesty's Royal Signature, for passing under the Great Seal of the Realm a Commission conformable to the said Draft which is hereunto annexed.

Our Most Illustrious Order of Saint Patrick, Knight Grand Commander of Our Most Exalted Order of the Star of India, Star of Order of the andPrincipal Grand Master Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Commander of Our Most Eminent Order of the Indian Empire, Knight Grand Oross of Our Royal Victorian Order, Grand Master and Principal Knight Grand Cross of Our Most Excellent Order of the British Empire; Our Most dear and entirely beloved Son and Most faithful Counsellor Albert Frederick Arthur George, Duke of York, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; Our Most dear and entirely beloved Son and Most faithful Counsellor Henry William Frederick Albert, Duke of Gloucester, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight of Our Most Illustrious Order of Saint Patrick, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; and Our Most dear and entirely beloved Son George Edward Alexander Edmund, Duke of Kent, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; Of Our most especial grace certain knowledge and mere motion do nominate and appoint Our said Most dearly beloved Consort The Queen and Our said Most dearly and entirely beloved Sons The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, to be Our Counsellors of State until the further signification of Our Pleasure and We do by these Presents give and grant unto Our said Counsellors of State or any two of them full power and authority from henceforth until the further signification of Our Pleasure to summon and hold on Our behalf Our Privy Council and to signify thereat Our approval of any matter or thing to which Our approval in Council is required and to approve and sign on Our behalf any of the documents specified in the Schedule hereunto annexed and further to do on Our behalf any of the other matters and things specified in the said Schedule, and to do on Our behalf any matter or thing which appears to them necessary or expedient to do on Our behalf in the interests of the safety and good government of Our United Kingdom, India, Our Colonies and the Protectorates and Territories administered under Mandate by Our Government in the United Kingdom; save only that they Our said Counsellors of State, The Queen, The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, shall not dissolve Parliament or in any manner grant any rank, title, or dignity of a Peerage or act in any manner or thing on which it is signified by Us or appears to them that Our special approval should be previously obtained; and We further direct that until the further signification of

Our Royal Pleasure, These Presents shall take effect notwithstanding the death or incapacity of any of Our said Counsellors of State, The Queen, The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, so long as two of those Counsellors of State remain capable of acting thereunder.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS FOR THE NORMAL RECRUITMENT BY OPEN COMPETITIVE SELECTION OF PROBA-TIONARY ASSISTANT ENGINEERS (MALE) IN THE ENGINEERING DEPARTMENT OF THE POST OFFICE.

- N.B.—These regulations are liable to alteration from time to time. It is anticipated that competitions, when required, will normally be held annually in the spring of the year.
- 1. Candidates must have attained the age of 20 and must not have attained the age of 25 on the 1st March of the year in which the competition is held.

In reckoning age for this purpose a candidate may deduct any time, up to a maximum of two years, which he has spent in an approved works or in post-graduate research work in an approved laboratory; and candidates who have served, or are serving, in the Navy, Army, or Air Force may deduct from their actual age any time during which they have so served.

Assistant Traffic Superintendents in the Post Office who are otherwise eligible, or who after three years' approved service in the Traffic Branch receive a nomination by the Engineer-in-Chief, may be granted an extension of age in respect of the period of their employment on traffic work in the Post Office, up to a maximum of five years, inclusive of any extension claimed for time spent in an approved engineering works.

2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

3. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Navy, Army, or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Postmaster-General.

Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent, cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

- 4. Applications for admission to a competition for these appointments must be made at such time and in such manner as the Civil Service Commissioners may appoint; an application cannot be recorded until a competition has been announced.
- 5. The Civil Service Commissioners will take such steps as they think most appropriate to make known the existence of any vacancies which it may be desired to fill on any one occasion.
- 6. In order to be eligible for appointment a candidate must normally either have passed an examination qualifying for an honours degree in engineering or possess qualifications equivalent in the opinion of the Civil Service Commissioners, or in the case of a man serving in the Post Office must have a nomination from the Postmaster-General. Exceptionally a candidate may be admitted who has passed an examination qualifying him for an honours degree and possesses high qualifications of a suitable character in physics or chemistry. candidates other than those nominated are expected to have taken a full course at an institution of university rank. Higher National Certificates will not be regarded as equivalent to degrees.

A candidate who is in the last year of his degree course and is taking his final examination in the summer of the year in which the competition is held may be admitted to compete; but such a candidate will not be eligible for an appointment unless at his final examination in the summer of the year in which the competition is held he attains the standard of an honours degree, and no steps will be taken for his appointment until the result of that examination is known.

- 7. When the list of applications in respect of a competition has been closed, the credentials of all the candidates will be examined by the Civil Service Commissioners, who may, if they so desire, invite the assistance of officers of the General Post Office; and those candidates who appear to have the requisite qualifications and to be best fitted for appointment will be summoned to an interview before a Selection Board, who will recommend for the vacancies existing those candidates who appear to them to possess the highest qualifi-The decision of the Selection Board will be final. The Board will be constituted by the Civil Service Commissioners in consultation with the authorities of the General Post Office, who will be represented on the Board.
- 8. The appointment of selected candidates will be subject to their satisfying the Civil Service Commissioners of their eligibility in respect of age, nationality, health, and character, and will not be confirmed unless and until they have passed the prescribed period of probation to the satisfaction of the Postmaster-General.

9. A fee of 5s. will be required from every candidate applying for admission to a competition; this fee is not returnable in any circumstances. A further fee of £4 15s., being the balance of the prescribed fee of £5, will be required from every candidate selected for appointment, before the issue of the certificate of qualification for appointment.

10. Candidates may submit with their application for admission to the competition reports or recommendations on their experience or qualifications from previous employers or the authorities at the colleges or schools at which

they have been trained.

Any attempt, direct or indirect, on the part of a candidate to enlist support for his application through persons other than those mentioned in the previous paragraph will disqualify him for appointment.

The Civil Service Commissioners further give notice of a competition to be held under

the foregoing Regulations.

The number of appointments to be made on the result of this competition will be not less than 20, provided so many candidates are recommended by the Selection Board as fully qualified.
