PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS (SCOTLAND), 1932.

PUBLIC HEALTH (IMPORTED FOOD) AMENDMENT REGULATIONS (SCOTLAND), 1933.

The Department of Health for Scotland give notice, in pursuance of the above-named Regulations, that they hereby recognise for the purposes of item (b) of the Second Schedule to the Amendment Regulations, i.e. :—

(b) Lard, dripping, edible tallow, and all other rendered animal fats except oleo oil, oleo stearine, and premier jus ;

each of the Official Certificates of which particulars are given in the Schedule hereto as evidence that the meat to which it relates has been derived from an animal which was free from disease at the time of slaughter and has been dressed or prepared and packed with all necessary precautions for the prevention of danger to public health.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the package containing the meat and if the label has not in any other circumstances, or on any other occasion, been used as an Official Certificate; and where the Certificate is in the form of a stamp the recognition will apply only if the stamp is clearly impressed on the container.

The Department of Agriculture for Scotland hereby give notice that, in exercise of their powers under the Destructive Insects and Pests Acts, 1877 to 1927, they have made on 14th April 1936 an Order entitled The Sale of Diseased Plants (Scotland) Order of 1936. The Order which comes into force on 15th May 1936 replaces The Sale of Diseased Plants (Scotland) Order of 1922 and The American Gooseberry Mildew (Scotland) Order of 1920.

In terms of the Order it is an offence to sell, offer or expose for sale, or after sale to deliver, for planting, any plant which is substantially affected by any of the following insects or pests:—Fruit Tree Cankers, American Gooseberry Mildew, Silver Leaf, Black Currant Mite, Woolly Aphis, all Scale Insects, Brown Tail Moth, Rhododendron Fly and Onion and Leek Smut; any plant which bears evidence of having been substantially affected by the Apple Capsid; any tomato or cucumber plant substantially affected by the Greenhouse White Fly; and any potatoes or Narcissus or Daffodil plants or bulbs which are visibly rendered unfit for planting by reason of their being or having been affected by any insect or pest. The expression "plant" includes tree and

shrub, and the seeds, tubers, bulbs, layers, cuttings or any other parts of a plant.

The Order, which comes into force on 1st May 1936, imposes restrictions on the importation into Scotland from Belgium of certain kinds of horticultural produce. The Order has been made in consequence of the spread of the Colorado Beetle into Belgium.
