UNEMPLOYMENT INSURANCE ACT, 1935.

MERCHANDISE MARKS ACT, 1926. Reference to the Standing Committee.

In accordance with the provisions of subsection (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that they have referred to the Standing Committee appointed by them under the Act an application for the making of an Order in Council amending Part I. of the Merchandise Marks (Imported Goods) No. 2 Order, 1928, so as to provide that the indication of origin required by that Order to be applied to imported sanitary ware of pottery shall be applied in a prescribed position and in letters of a minimum size.

Part I. of the Merchandise Marks (Imported Goods), No. 2 Order, 1928, renders it unlawful to import into the United Kingdom, or, if

imported, to sell or expose for sale in the United Kingdom, *inter alia*, any goods of the above description, unless they bear an indication of origin stamped, printed, embossed, or impressed on each article indelibly.

TRADE BOARDS ACTS, 1909 AND 1918.

PAPER BOX TRADE BOARD (GREAT BRITAIN).

Proposal to vary minimum rates of wages.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April 1927, the Paper Box Trade Board (Great Britain) hereby give notice that they propose to vary minimum rates of wages at present set out in their Notice B.(19) dated 17th June 1933, so as to provide for the current rates of wages being paid for a week of 45 hours instead of 48 hours.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the proposed variations which may be lodged with them within two months from 8th October 1937. Any such objection should be in writing and signed by the person making the same (adding his or her name and address), and should be sent to the Secretary, Paper Box Trade Board, Metropole Buildings, Northumberland Avenue, London, W.C.2. It is desirable that objections should state precisely, and, so far as possible, with reasons, what is objected to.

Civil Service Commission, October 5, 1937.

The Civil Service Commissioners hereby give notice that, with the approval of the Lords Commissioners of His Majesty's Treasury, Clause 12 of the General Regulations respecting appointment to His Majesty's Civil Establishments, made under the Order in Council of the 22nd July 1920 and published in the London Gazette of the 6th April 1923, has been amended to read as follows, viz.:—

12. Every candidate shall satisfy the Commissioners that he or she is a natural-born British subject, the child of a person who is or was at the time of death a British subject. Provided that exception may be made:—

- (a) In the case of candidates who are serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.
- (b) In the case of persons who, being British subjects, and having served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918, (a) are serving and have served for not less than six months in unestablished uncertificated employment which in normal course, by departmental custom or by the grant of establishment to an unestablished class, confers a claim to nomination singly or by limited competition for established and certificated appointment and are nominated for that established and certificated appointment, or (b) are serving and have served in unestablished uncertificated employment for at least ten years, or (c) have satisfactorily completed a period of not less than ten years' service on full pay in His Majesty's Regular
- (c) In the case of persons serving in unestablished uncertificated employment which in normal course, by departmental custom or by the grant of establishment to an unestablished class, confers a claim to nomination singly or by limited competition for established and certificated appointment, who are nominated for that established and certificated appointment, and (a) who satisfy the rule in respect of nationality for established appointment which was in force when their unestablished service began or (b) who being natural-born British subjects have served in unestablished uncertificated employment for at least ten years.

(d) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(e) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

(f) In respect of appointment to the Royal Mint and its Branches overseas, in the case of persons who have acquired British nationality by any annexation of territory to the Crown, and in the case of the children of such persons who are themselves of British nationality.

If the Commissioners are satisfied in the case of any candidate who is a British subject, but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate

is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible, provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

A candidate will not be eligible for assignment or appointment to the Foreign Office or services under the control of the Secretary of State for Foreign Affairs unless he is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within those Territories, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs of this regulation, he may be admitted to appointment or competition by special permission of the Secretary of State for Foreign Affairs.

NATIONAL HEALTH INSURANCE ACT, 1936.

SHEEP SCAB MOVEMENT AND DOUBLE DIPPING AREAS.

The following Areas are "Movement Areas" for the purposes of Part II. of the Sheep Scab Order of 1928:—

Inverness.—An Area comprising:—

The Islands known as the Outer Hebrides (except the Islands of St. Kilda, Dune, Soay, and Boreray; and except the parish of North Uist and all the islands therein, together with the Island of Berneray, in the parish of Harris, and all the grazing islands attached thereto and the Island of Barra and the adjacent islets attached to the holdings of Barra), in the county of Inverness.

Ross and Cromarty.—An Area comprising:—

The Island of Lewis, including the smaller islands adjacent thereto, in the county of Ross and Cromarty.

The movement of sheep out of the following area is regulated by the North Uist (Movement of Sheep) Order of 1934:—

An area in the county of Inverness comprising the parish of North Uist and all the islands therein, together with the Island of Berneray, in the parish of Harris, and all the grazing islands attached thereto.

RE-DIVISION OF THE BURGH INTO WARDS AND DEFINITION OF THE PROPOSED NEW BOUNDARIES THEREOF.

Third Ward.—That part of the Burgh situated to the South and West of the proposed new southern boundary of the Second Ward specified above,

the Sheriff-Substitute pronounced the following Interlocutor:—

"Oban, 1st April 1937.—The Sheriff-Substitute, having resumed consideration of the foregoing Petition and relative productions and having considered the evidence led for the Petitioners, and in respect that after due intimation no party has appeared to object or to be heard in reference thereto, and being satisfied that the proposed redivision of the three Wards of the Burgh of Oban is reasonable and expedient and ought to be granted in terms of Section 19 of the Town Councils (Scotland) Act, 1900, therefore finds and declares in terms of the Prayer of the Petition; defines the New Boundaries of the said three

"Wards in accordance with the scheme set forth in the Petition and as delineated and coloured red on the Plan, No. 2 of Process, signed and docquetted as relative thereto; and reaffirms the existing apportionment of three Councillors to each Ward; grants Warrant to record the said Petition and this Deliverance in the Books of Court and in the Minute-Book of Petitioners.
