#### DISEASES OF FISH.

THE DISEASES OF FISH (DELEGATION OF POWERS) ORDER, 1937, dated the 20th October 1937, made by the Secretary of State in pursuance of Section 11 (d) of the Diseases of Fish Act, 1937.

1. In pursuance of the power conferred upon him by Section 11 (d) of the Diseases of Fish Act, 1937, the Secretary of State hereby delegates to the Fishery Board for Scotland all the powers exercisable by him under that Act, with the exception of the power to make regulations in terms of Section 9 and the power conferred by Section 1 (3) (c) to determine, with the consent of the Treasury, the fee to be paid on the grant of a licence under the Act.

2. This Order may be cited as the Diseases I

of Fish (Delegation of Powers) Order, 1937, and shall have effect as from the 1st November 1937.

1937 Review of the Operation of the Railway Freight Rebates Scheme and Application in respect of Administrative Expenses

NOTICE is hereby given that the Railway Rates Tribunal will sit at 10.30 a.m. on Wednesday the 17th November 1937, in Court "A," Judges' Quadrangle, Royal Courts of Justice, London, W.C.2, to review the operation of the Railway Freight Rebates Scheme for the year ending 30th September 1937, pursuant to the provisions of Part I. of the Eleventh Schedule to the Local Government Act, 1929, and the Railway Freight Rebates Act, 1936.
