The KING's Most Excellent Majesty in Council

WHEREAS the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor, dated 4th November 1937, pronunced by the Sheriff of Stirling, Dumbarton and Clackmannan, finding that the continued use for burial of the Burial Ground at Camelon Parish Church in the Burgh and Parish of Falkirk and County of Stirling would be dangerous to health and offensive and contrary to decency:

And whereas in the said Representation it is recommended that burials be forthwith discontinued in the said Burial Ground in terms of Section 5 of the aforesaid Act, except for the reservation of the right of burial in the cases hereinafter specified:

And whereas by an Order in Council of the 15th day of March 1938 Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 26th day of April next and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof should be fixed on the doors of the Church of, or on some other conspicuous places within, the parish of Falkirk one month before the said 26th day of April:

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz.:—

That burials be forthwith discontinued, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, in the Burial Ground at Camelon Parish Church in the Burgh and Parish of Falkirk and County of Stirling, except for the burial of—

- (1) Spouses of persons who are already buried in the said Burial Ground;
- (2) Unmarried sons and daughters whose parents are already buried therein;
- (3) Persons whom the Town Council of the Burgh of Falkirk may specially authorise to be buried therein; and
 - (4) Cremated human remains.

Provided that the exercise of the right of burial be not injurious to health or offensive or contrary to decency, that notice be given to the Sanitary Inspector for the Burgh of Falkirk not later than the day preceding that on which a grave has to be opened and that no burial, except the burial of cremated human remains, shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

The Department of Agriculture for Scotland hereby give notice that, in exercise of their powers under the Destructive Insects and Pests Acts, 1877 to 1927, they have made the Importation of Raw Cherries (Scotland) Order of 1938 by which the landing in Scotland after 18th May 1938 of any raw cherries grown in any European country other than Spain, France, Italy, Germany, and Hungary is prohibited, unless each consignment is accompanied by a certificate of origin visé by a competent authority in the country of origin, stating the country and place where the cherries were grown.

Cherries grown in Spain will not be admitted after 18th May.

Cherries grown in France will be admitted until 27th May if accompanied by a certificate of origin; after that date importation will be prohibited except of cherries certified to have

been grown within the zone specified in the Schedule to the Order.

Cherries grown in Italy will be admitted until 12th June if accompanied by a certificate of origin. During the period 13th to 23rd June, only cherries certified to have been grown either within the region of Emilia or within the Province of Verona will be admitted. After 23rd June the importation of cherries grown in Italy is prohibited.

Cherries grown in Germany will be admitted until 26th June if accompanied by a certificate of origin; after that date no cherries grown in Germany will be admitted except those certified not to have been grown south of latitude 53° N. or in East Prussia.

Cherries grown in Hungary will be admitted until 9th June if accompanied by a certificate of origin; after that date the importation of cherries grown in Hungary is prohibited.

The Order shall remain in force until the thirtieth day of September nineteen hundred and thirty-eight.

Inverness.—An Area comprising:—

The Islands known as the Outer Hebrides (except the Islands of St. Kilda, Dune. Soay, and Boreray; and except the parish of North Uist and all the islands therein, together with the Island of Berneray, in the parish of Harris, and all the grazing islands attached thereto and the Island of Barra and the adjacent islets attached to the holdings of Barra), in the county of Inverness.

Ross and Cromarty.—An Area comprising:—

The Island of Lewis, including the smaller islands adjacent thereto, in the county of Ross and Cromarty.

The movement of sheep out of the following area is regulated by the North Uist (Movement of Sheep) Order of 1934:—

An area in the county of Inverness comprising the parish of North Uist and all the islands therein, together with the Island of Berneray, in the parish of Harris, and all the grazing islands attached thereto.
