TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday the 22nd July 1938, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 25th July 1938 to Saturday

the 30th July 1938 inclusive, and will be payable at three months after date.

- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England,
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

CONSTITUTION OF THE COUNTY COUNCIL OF THE COUNTY OF LANARE

ORDER BY THE SECRETARY OF STATE.

WHEREAS the contents and boundaries of the electoral divisions of the County of Lanark, the number of County Councillors for the County and the apportionment of these County Councillors between the landward area and the burghs entitled to be represented on the County Council were determined by Orders dated the 25th October 1929 and the 20th September 1935 made by the Secretary of State under Section 8 of the Local Government (Scotland) Act, 1929, and Section 51 of the Local Government (Scotland) Act, 1889, respectively:

AND WHEREAS the boundaries of certain burghs in the County have been extended, and it is desirable to alter the description and contents of the electoral divisions of Bankhead (No. 19); Carmunnock (No. 20); Newmains (No. 30); Stepps (No. 39); Springboig (No. 40); Chryston (No. 41); Bellshill South (No. 46); and Old Monkland (No. 53) accordingly:

AND WHEREAS the County Council have represented to me that it is desirable to alter the contents and boundaries of the electoral division of Baillieston (No. 52) and to increase the number of County Councillors for the County and the number of County Councillors to be elected for the landward area of the County:

AND WHEREAS I am of opinion that it is expedient to give effect to their representations to the extent and in the manner hereinafter provided:

Now THEREFORE I, the undersigned, one of His Majesty's Principal Secretaries of State, in virtue of the powers conferred on me by Section 5 of the Local Government (Scotland) Act, 1889, as read with the Local Government (Scotland) Act, 1929, do hereby order as follows:—

. 1. The Order of the Secretary of State dated 25th October 1929, as read with the Order dated 20th September 1935, so far as relating to the electoral divisions of Newmains (No. 30); Stepps (No. 39); Springboig (No. 40); Chryston (No. 41); Bellshill South (No. 46); and the Order of the Secretary of State dated 20th September 1935 so far as relating to the electoral divisions of Bankhead (No. 19) and Carmunnock (No. 20) are hereby recalled, and from and after the date hereof the said electoral divisions shall have the following descriptions and contents, viz.:—

DEPARTMENT OF HEALTH FOR SCOTLAND.

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS (SCOTLAND), 1937.

The Department of Health for Scotland give notice, in pursuance of the above-named Regulations, that they hereby recognise each of the Official Certificates of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Department; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or to the package containing the meat or meat product and if the label has not in any other circumstances or on

any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.
