TOWN AND COUNTRY PLANNING
(SCOTLAND) ACT, 1932.RENFREW COUNTY PLANNING
SCHEME.

NOTICE is hereby given that—

(1) On the twenty-seventh day of December 1938 the Department of Health for Scotland notified their approval of the Resolution of the County Council of the County of Renfrew, dated the fourth day of July 1938, deciding to prepare the above Planning Scheme with reference to an area situate in the County of Renfrew.

(2) The Map defining the area to which the Resolution applies has been deposited at the temporary Town Planning Office, Education Offices, 16 Glasgow Road, Paisley, and will be open for inspection by all persons interested, without charge, between the hours of 10 o'clock forenoon and 4 o'clock afternoon on week-days, except Saturdays, and between the hours of 10 o'clock forenoon and 12 o'clock noon on Saturdays. Certified copies of the Map have been deposited at the undernoted Offices, and will be open for inspection between the hours of 10 o'clock forenoon and 12 o'clock noon on week-days, except Saturdays, viz. :—

First District Council Office, 105 Kilmarnock Road, Giffnock;

Second District Council Office, 10-12 Glen Street, Barrhead;

Third District Council Office, Bishopton;

Fourth District Council Office, Ludovic Square, Johnstone;

Fifth District Council Office, Kilmacolm.

(3) Any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the County of Renfrew and any local association representing business or industry may, by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the County Council to register without charge his or their name and address for the service of subsequent notices relating to the Scheme.

Under the Town and Country Planning (General Interim Development) Order (Scotland), 1933,* the development of land in the area during the preparation of the Scheme is permitted to the extent specified in the Order and in addition the County Council are empowered to permit other development in the area during this period with a view in either case to protecting the development from the risk of removal or alteration without compensation under the Scheme when approved and in operation. Prints of the Order have been deposited along with the aforesaid Map and the certified copies thereof.

The County Council intend to proceed as soon as may be with the preparation of a Draft Scheme, and any suggestions as to proposals to be included in the Draft Scheme should be sent in writing to the County Clerk.

LIGHTING DISTRICT.

HAMILTON LODGING HOUSE COMPANY
LIMITED.

A PETITION has been presented to the Court of Session by Hamilton Lodging House Company Limited, incorporated under the Companies Acts, 1862 to 1898, and having its Registered Office at 63 Almadra Street, Hamilton, for Confirmation of (a) an

alteration of the provisions of the Company's Memorandum of Association with respect to its objects set forth in a Special Resolution of the Company passed at an Extraordinary General Meeting of the Company held on 23rd November 1938; and (b) the Reduction of the Capital of the said Company resolved on by Special Resolution passed at an Extraordinary General Meeting of the Company held on 23rd November 1938. The said Special Resolutions are as follows :—

" 1. That Clause III. (1) of the Memorandum of Association of the Company (which relates to the objects for which the Company is established) be altered by deleting the words 'and other Towns' in the County of Lanark' occurring in the second line thereof, and substituting therefor the words 'and elsewhere in Scotland.'"

" 2. That the Share Capital of the Company be reduced from £12,000, divided into 12,000 Shares of £1 each (of which 9840 Shares of £1 each have been issued and are fully paid and 2160 are unissued), to £4920, divided into 9840 Shares of 10s. each, and that such reduction be effected (a) by returning to the Holders of the said 9840 Shares paid-up Capital to the extent of 8s. per Share; (b) by cancelling paid-up Capital to the extent of 2s. per Share upon each of said 9840 Shares; (c) by cancelling the whole of the 2160 unissued Shares of £1 each which have not been taken or agreed to be taken by any person; and (d) by reducing the nominal amount of each of the said 9840 Shares from £1 to 10s."

In the said Petition the following Interlocutor has been pronounced :—

" The Vacation Judge appoints the Petition to be
