WHEREAS His Majesty, in pursuance of the Regency Act, 1937, was pleased, by Letters Patent dated the 5th day of May 1939, to delegate and grant unto Her Majesty The Queen, His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.C.M.G., G.C.V.O., His Royal Highness The Duke of Kent, K.G., K.T., G.C.M.G., G.C.V.O., Her Royal Highness The Princess Royal, C.I., G.C.V.O., G.B.E., and Her Royal Highness Princess Arthur of Connaught, or any two of them, as Counsellors of State, full power and authority during the period of His Majesty's absence from the United Kingdom to summon and hold on His Majesty's behalf His Privy Council and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor, dated 30th March 1939, pronounced by the Sheriff-Substitute of Perth and Angus, at Forfar, finding that the Burial Ground known as the Old Churchyard at Newtyle, in the Parish of Newtyle and County of Angus, is so crowded as to be dangerous to health or offensive or contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Burial Ground in terms of Section 5 of the aforesaid Act, except for the reservation of the right of burial of—

- (9) Miss Isabella Robertson M'Nicoll, East Belmont Street, Newtyle;  
 (10) Miss Isabella Dingwall, Auchterneed, Newtyle;  
 (11) Miss J. A. Robertson, Belmont Street, Newtyle;  
 (12) Hugh Gray and his wife, both residing at Graylands, Newtyle;  
 (13) Persons whom the County Council of the County of Angus may specially authorise to be buried therein; and  
 (14) Cremated human remains.

Now, therefore, His Royal Highness The Duke of Gloucester, His Royal Highness The Duke of Kent, Her Royal Highness The Princess Royal, and Her Royal Highness Princess Arthur of Connaught are pleased, on His Majesty's behalf, being authorised thereto by the said Letters Patent, to give Notice of such Representation and to Order that the same be taken into consideration on the 10th day of July next.

And are further pleased to direct that this Order, or Notice thereof, be published in the Edinburgh Gazette, and that copies of this Order or Notice thereof be fixed as required by the aforesaid Act on the doors of the Church of, or on some other conspicuous places within, the Parish of Newtyle one month before such Representation is considered.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :—

**REGULATIONS FOR THE APPOINTMENT BY COMPETITIVE SELECTION OF MALE CIPHER OFFICERS (UNESTABLISHED) IN THE WAR OFFICE.**

*N.B.—These Regulations are liable to alteration from time to time.*

1. Application may be made at any time to the Under-Secretary of State, The War Office, for inclusion on the list of candidates desiring appointment.

2. A candidate must not have attained the age of 50 on the date of meeting of the Selection Board, and must have held a commission in the Regular Army, or have served as a commissioned officer with the Military Forces during the Great War.

3. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made:—

(a) In the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.

(b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

The consent of the authorities of the War Office is required before a candidate either of whose parents was of other than British nationality at birth can be appointed to that Department.

4. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Army, Navy, or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

5. On the occurrence of a vacancy, the list of candidates desiring appointment will be scrutinised by the War Office, and such candidates as appear to be best qualified will be invited to attend before a Board consisting of representatives of the War Office and of the Civil Service Commissioners. The Board will select for appointment to the vacancies existing those candidates who appear to them to possess the highest qualifications provided they find so many suitable; and the decision of the Board will be final.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not

personally acquainted with the candidate's previous work.

6. The necessary number of candidates will be appointed on an unestablished and temporary basis, subject to their satisfying the Civil Service Commissioners that they are eligible for appointment in respect of age, nationality, health, and character and to the payment of a fee of £1.

7. The appointments will be temporary; but the candidates appointed will be eligible to be considered for appointment in an established capacity as vacancies arise, provided they are then under 50 years of age and have served for not less than one year continuously in the War Office as Temporary Cipher Officer. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a fee of £1, being the balance of the prescribed fee of £2, is payable before the certificate of qualification can be issued.

TOWN COUNCIL OF ABERDEEN.  
ROAD TRAFFIC ACT, 1930.

SHEEP SCAB MOVEMENT AND DOUBLE-DIPPING AREAS.
