#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 659 of the Merchant Shipping Act, 1894 (which is a Section în Part XI. of that Act), it is (amongst other things) enacted that His Majesty may by Order in Council fix the establishments to be maintained by each of the General Lighthouse Authorities on account of the services of lighthouses, buoys and beacons or the annual or other sums to be paid out of the Mercantile Marine Fund in respect of those Establishments:

And whereas by Section 738 of the Merchant Shipping Act, 1894, it is (amongst other things) enacted that where His Majesty has power under that Act or any Act thereafter to be passed amending the same to make an Order in Council His Majesty may from time to time make that Order in Council and by Order in Council revoke, alter or add to any Order so made:

And whereas by Section 1 of the Merchant Shipping (Mercantile Marine Fund) Act, 1898, it is (amongst other things) provided that references in Part XI. of the Merchant Shipping Act, 1894, to the Mercantile Marine Fund shall be construed as references to the General Lighthouse Fund by the now reciting Act constituted:

And whereas, by the Northern Lighthouse Board (Establishment) Order, 1936, and the Northern Lighthouse Board (Variation of Establishment) Order, 1937, the establishment to be maintained by the Commissioners of Northern Lighthouses being one of the General Lighthouse Authorities referred to in the Merchant Shipping Act, 1894, and the salaries to be paid out of the General Lighthouse Fund in respect of that establishment were duly fixed:

And whereas it is expedient to fix such additional sums to be paid out of the General Lighthouse Fund to the present holders of the posts of Secretary, Accountant, and Senior Clerk respectively as are hereinafter provided:

Now, therefore, His Majesty, by virtue of the power vested in Him by the Merchant Shipping Act, 1894, and of any other powers Him thereunto enabling, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1. This Order may be cited as the Northern Lighthouse Board (Establishment) Order, 1939, and shall come into operation on the date of publication in the London Gazette.

2. Notwithstanding anything contained in the Northern Lighthouse Board (Establishment) Order, 1936, and the Northern Lighthouse Board (Variation of Establishment) Order, 1937—

- (a) the salary of Mr. J. Glencorse Wakelin, at present Secretary, shall be £1350 per annum with effect from the 1st day of January 1939, rising to £1400 per annum on the 1st day of January 1940;
- (b) Mr. Robert Johnston, at present Accountant, shall be granted an allowance of £50 per annum with effect from the 1st day of January 1939;

(c) the salary of Mr. John Simpson, Senior Clerk, shall be £695 5s. per annum with effect from the 1st day of January 1939, rising by annual increments of £25 to a maximum of £730 per annum.

3. The sums payable under the provisions of this Order shall be paid out of the General

Lighthouse Fund.

4. The Interpretation Act, 1889, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

5. All Officers on the active, retired, and reserve lists of the Regular Army and Territorial Army, except Officers of the Household Cavalry and the Brigade of Guards, and except Officers of the Indian Services, Burma Services, Indian Army and Burma Army, and Colonial Service and Colonial Forces, will communicate with and obtain their cards from the Under-Secretary of State, War Office.

6. All Officers on the active list of the Royal Air Force and Officers of the Auxiliary Air Force will obtain their cards through the usual channels. Officers of the Reserve of Air Force Officers, Officers of the Royal Air Force Volunteer Reserve, Officers of the Auxiliary Air Force Reserve of Officers, and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards from the Under-Secretary of State, Air Ministry, Kingsway, W.C.2

7. All Officers of His Majesty's Civil Service will communicate with and obtain their cards from the Department under which they serve.

8. All Officers of the Indian Services, Burma Services, Indian Army and Burma Army, whether on the active or retired lists, will communicate with and obtain their cards from the Political A.D.C. to the Secretary of State at the India and Burma Offices, Whitehall.

9. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards from the Ceremonial and Reception Secretary, Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, the War Office, for their cards, supporting their application in General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.

10. Gentlemen connected with the Treasury, the Foreign Office, and other Government

Departments will make their applications through the Private Secretaries to the Ministers

of the respective Departments.

#### WORKMEN'S COMPENSATION ACT, ACT, 1925-1930.

#### FACTORIES ACT, 1937.
