### ACT OF ADJOURNAL

RELATIVE TO PROCEDURE IN CRIMINAL TRIALS UNDER SECTION 3 OF THE ADMINISTRATION OF JUSTICE (EMERGENCY PROVISIONS) (SCOTLAND) ACT, 1939, HEREINAFTER REFERRED TO AS "THE ACT."

At Edinburgh, the tenth day of October nineteen hundred and thirty-nine.

The Lord Justice-General, Lord Justice-Clerk, and Lords Commissioners of Justiciary, by virtue of the powers conferred upon the Court by an Act passed in the Third Session of the Second Parliament of King Charles the Second entituled, "Act concerning the Regulation of Judicatories" and "The Criminal Procedure (Scotland) Act, 1887," 50 & 51 Vict., c. 35,

Do hereby ENACT and DECLARE that from and after the passing hereof, the following provisions shall have effect, viz.:—

I. Any Application made by or on behalf of the Lord Advocate or by or on behalf of the Accused under Section 3 (1) of the Act, to direct that the provisions therein should not apply by reason of the gravity of the matters in issue, may be made to the Clerk of Justiciary, 2 Parliament Square, Edinburgh, by letter or

telegram addressed to said Clerk.

II. On receipt of such Application the Clerk shall forthwith submit it and a copy of the Indictment in the case to a Court of not less than three Judges of the High Court of Justiciary, who may dispose of the Application in Chambers or otherwise. On judgment being delivered by the Court the Clerk shall endorse the finding of the Court on the Record Copy of the Indictment. Thereafter at the trial of the cause a copy of the endorsement shall be entered in the Record of the proceedings.

III. This Act of Adjournal shall come into operation on the date hereof and shall be printed and published in the Edinburgh Gazette.
