To provide as to the standard rate of dividend on the consolidated ordinary stock, and the reduction or increase of the same according as the price of gas supplied by the Company is increased or reduced above or below the prices mentioned in the Draft Order.

To amend Clause 34 (Power to create a reserve fund out of dividends in excess of the standard rates of dividend and application thereof) of the Stirling Gas Act, 1898, as the Order may provide.

To empower the Company to create a special purposes fund and a renewal fund, and to grant pensions to employees and others, all as set out in the Draft Order or as the Board of Trade may order.

To extend the limits of supply of the Company so that they shall extend to and include in addition to the existing limits the following, viz:—
