The Lords Commissioners of His Majesty's Treasury hereby give notice that They have made an Order under Section 19 of the Import Duties Act, 1932, as applied by Section 6 of the Finance Act, 1936, viz. :—

The Additional Import Duties (No. 8) Order, 1939, providing for the amendment of the schedules to the Additional Import Duties (No. 3) Order, 1937, and the Additional Import Duties (No. 7) Order, 1939, relative to certain iron and steel goods imported under specified conditions including the production of quota certificates.

## TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 15th December 1939, at 1 p.m., for Treasury

Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £65,000,000.

2. The Bills will be in amounts of £5000, £10,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday the 18th December 1939 to Saturday the 23rd December 1939 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.
