DISEASES OF ANIMALS ACTS. 1894 to 1937.

Swine Fever (Amendment) Order of 1940 Modifies the provisions of the Swine Fever Order of 1938 in the following respects:-

I. Prescribes the manner of service of notices (Form A) where the premises on which swine fever exists or is suspected to exist are a slaughterhouse or bacon factory.

II. Provides for the use of a solution containing not less than two per cent. of available chlorine as an alternative to an "approved disinfectant" for any disinfection required under the Swine Fever Order of 1938.

III. Defines the term "castrator" as "a person who castrates for reward."

IV. Redefines the term "pig dealer" as Agriculture a caperson habitually engaged in the trade or business of buying and re-selling pigs, but a Annes, Lancs.

person shall not be deemed to be a pig dealer by reason only that he sells for slaughter pigs which he has purchased and fed for that purpose."
