To the King's Most Excellent Majesty.

We, the Merchants, Manufacturers, and other Inhabitants of the City of Glasgow, assembled this day, humbly request permission to lay at the foot of the throne of our beloved Sovereign our heartfelt congratulations upon the magnanimity and valour so successfully displayed by the Spanish patriots, in opposing the deep and dishonourable designs of the unprincipled and sanguinary ruler of France.

Along with your Majesty's other loyal subjects, we most feelingly participate with the Spanish people in every event which may tend to restore that honourable nation to the rank in the scale of independent states, which it heretofore held, and which its recent patriotic efforts have rendered it still more worthy of possessing. Inspired with these sentiments, we, the inhabitants of a free country, enjoying all those blessings which an envied constitution, and the love and protection of an exemplary Sovereign can bestow, cannot refrain from expressing our unqualified approbation of the prompt, efficacious, and liberal policy pursued by your Majesty, in at once forgetting all former hostility, and in holding out to a gallant people, threatened with oppression, the vigorous and unconditional assistance of these kingdoms We feel a pride in being the subjects of a

monarch whose zeal and whose power are thus exerted in defence of the liberties and best interests of mankind. We rejoice in the opportunity afforded us of assuring your Majesty of the firm and steady support of the loyal citizens of Glasgow in the prosecution of so arduous and so honourable an undertaking; and we confidently hope that, through the enthusiasm and unanimity of the Spanish and Portuguese nations, aided by your Majesty's arms, this glorious struggle for freedom will, under the favour of divine providence, revive a spirit of independence in the other nations of the continent, and terminate in the utter discomfiture of the foe.

That Almighty God may bless and prosper the cause in which your Majesty is engaged; that he may crown your Majesty's arms with signal success; and that he may long preserve a life upon which the fate of civilized society so materially depends, is our most ardent wish and prayer.
