May it please your Majesty,
We, your Majesty's most dutiful and loyal subjects, the Ministers and Elders of the Provincial Synod of Argyll, met in Synod, beg leave to offer at the foot of the throne our unanimous tender of respectful attachment and unshaken fidelity to the best of Sovereigns.

Recognizing with reverence and awe the mysterious workings of divine providence in the calamitous events which have of late years occurred on the continent of Europe, by the progress of an upstart power, which, in its mad career of violent usurpation, threatens the subversion of all civil and religious establishments, we bless God, the great ruler among the native statements. tions, and sincerely congratulate your Majesty, that, amidst the general wreck of ancient governments, the British territories at home and abroad have, under the protecting care of divine providence, and by the steady conduct of your Majesty's councils, remained inviolate, and our civil and religious libertics unimpaired.
