THE ITABIRA IRON ORE COMPANY LIMITED (PRICE OF SHARES) ORDER, 1943, DATED THE 12TH APRIL 1943, MADE BY THE TREASURY UNDER REGULATION 78A OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

Whereas by the Itabira Iron Ore Company Limited (Transfer of Shares) Order, 1942, the Minister of Supply (hereinafter referred to as "the Minister"), in exercise of the powers conferred upon him by Regulation 78A of the Defence (General) Regulations, 1939, transferred all the shares of the Itabira Iron Ore Company Limited to his nominees as specified in the Order:

And whereas the shares so transferred were of the following three classes, that is to say:—

(a) 7 per cent. Cumulative First Preference Shares of £1 each.

(b) 7 per cent. Non-cumulative Second Preferred Shares of £1 each, and

(c) Ordinary Shares of £1 each:

And whereas the Treasury are of opinion that the prices hereinafter specified as the prices to be paid by the Minister respectively in respect of the said classes of shares so transferred as aforesaid are not less than the values of those shares respectively on the 6th day of March 1942 (being the date of the making of the said Transfer of Shares Order) as between a willing buyer and a willing seller buying and selling respectively without any knowledge of any arrangements or negotiations for the purposes of which, or in connection with which, the Minister's order was made:

Now, therefore, the Lords Commissioners of His Majesty's Treasury, in exercise of the powers conferred upon them by paragraph (2) of Regulation 78A of the Defence (General) Regulations, 1939, hereby make the following Order:

1. The prices to be paid by the Minister in respect of the shares of the Itabira Iron Ore Company Limited so transferred to his nominees as aforesaid shall be:

(a) in the case of the 7 per cent. Cumulative First Preference Shares, 15s. per share;

(b) in the case of the 7 per cent. Non-Cumulative Second Preferred Shares, 2s. 6d. per share; and

(c) in the case of the Ordinary Shares, 3d. per share.

2. This Order may be cited as the Itabira Iron Ore Company Limited (Price of Shares) Order, 1943.
