# BY THE KING. A PROCLAMATION.

GEORGE R.

Whereas our Parliament stands prorogued to Thursday the 8th day of December next, we, with the advice of our Privy Council, do hereby publish and declare, that the said Parliament shall be further prorogued on the said 8th day of of December next, to Monday the 16th day of January next; and we have given order to our Chancellor of that part of our united kingdom called Great Britain, to prepare a commission for proroguing the same accordingly: And we do further hereby, with the advice aforesaid, declare our royal will and pleasure that the said Parliament shall, on the said 16th day of January next, be held and sit for the dispatch of divers urgent and important affairs; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for shires and burghs, of the House of Commous, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said 16th day of January next.

Given at our Court at the Queen's Palace, the 23d day of November 1808, in the 49th year of our reign.
