PURCHASE TAX.

The Lords Commissioners of His Majesty's Treasury hereby give notice that they have made an Order under Section 20 of the Finance (No. 2) Act, 1940, entitled the Purchase Tax (Exemptions) (No. 1) Order, 1944, directing that as from the 17th April 1944 purchase tax shall cease to be chargeable in respect of picture frames of wood, plain, gilt, or coloured, with or without ornamental composition, which are made from moulding of a width not less at any point than 3 inches.
