SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

COUNTY OF RENFREW.

Under the Special Enactments (Extension of Time) Act, 1940, the Secretary of State made, on 30th June 1941, Orders which provided for an extension by three years of the time within which the County Council of the County of Renfrew (hereinafter referred to as "the Local Authority") may exercise the powers of compulsory purchase conferred upon them by the undermentioned Compulsory Purchase Orders. Subsequent Orders under the said Act have been made by the Secretary of State, the effect of which is to extend by two more years the time within which the Local Authority may exercise the said compulsory powers.

The Compulsory Purchase Orders referred to are as follows :—

(1) The Kilbarchan (No. 1A) Clearance Area Compulsory Purchase Order, 1937, as confirmed by the Kilbarchan (No. 1A) Clearance Area Compulsory Purchase Order, 1937, Confirmation Order, 1938.
