WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of February 1945 (C.W. 45290/44), in the words following,

viz. :-VIZ. :--"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas under the regulations for the Government of Your Majesty's Naval Service it is provided that Climate Pay may be paid during certain seasons to officers and men serving in specified localities at the following daily rates :--

"And whereas we consider that Climate Pay should be regarded as in the nature of compensation for the medical risks and discomforts of life afloat under tropical conditions. and that accordingly payment should be restricted exclusively to service afloat :

"And whereas the conditions of the present war have necessitated, and may in future necessitate, changes in the areas, times, and other conditions of payment of Climate Pay :

"And whereas we consider that the rate of Climate Pay for Commissioned Officers and Commissioned Officers from Warrant rank should be reduced to 2s. Od. a day:

Warrant rank should be reduced to 25. ou. a day. "We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction, with effect from 1st October 1943, payment of Climate Pay, in such areas, at such seasons, and subject to such conditions as may from time to time be agreed between us and the Lords Commissioners of Your Majesty's Treasury, at the following deily rates :-at the following daily rates :---

1. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.
