# STATUTORY RULES AND ORDERS, 1945, No 722. PUBLIC WORKS LOANS.

Further Regulations, dated June 12, 1945, made by the Public Works Loan Commissioners, and approved by the Treasury pursuant to section 41 of the Public Works Loans Act, 1875 (38 & 39 Vict. c. 89).

1. The Secretary or Assistant Secretary to the Public Works Loan Commissioners (hereinafter referred to as "the Loan Commissioners") shall from time to time certify to the National Debt Commissioners the amount required by the Loan Commissioners for the purposes of advances to be made under Section 9 of the Public Works Loans Act, 1875, and the date on which such advances are to be made.

2. There shall be established a Public Works Loans (Advances) Account at the Bank of England under the control of the Loan Commissioners. Upon receipt of any such certificate as aforesaid the National Debt Commissioners shall, on or before the day upon which the advances are due
