#### DRESSMAKING AND WOMEN'S LIGHT CLOTHING WAGES COUNCIL (SCOTLAND).

The Dressmaking and Women's Light Clothing Wages Council (Scotland) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) the revocation of the Order W.D.S. (34) dated 23rd May 1945, and for the fixing of specified statutory minimum remuneration in substitution for the minimum rates of wages at present in operation; and (2) for the amendment of the Order W.D.S. (24) dated 12th July 1945, which deals with holidays with pay and for the allowing of customary holidays and the fixing of holiday remuneration.
