In pursuance of Subsection (3) (a) of Section 1 of the Diplomatic Privileges (Extension) Act, 1944 (7 and 8 Geo. 6, Ch. 44) His Majesty's Principal Secretary of State for Foreign Affairs hereby gives notice of the following amendments of the list, published in the Edinburgh Gazette of the 6th March 1945, of persons upon whom immunities and privileges have been conferred by the Diplomatic Privileges (U.N.R.R.A.) ### DISTRIBUTION SCHEME No. 2—MORAR AREA.

THE Secretary of State for Scotland made on 5th May 1945 two Orders confirming respectively the "North of Scotland Hydro-Electric Board Distribution Scheme No. 1" and the "North of Scotland Hydro Electric Board Distribution Scheme No. 2" prepared by the North of Scotland Hydro Electric Board in accordance with Section 6 of the Hydro Electric Development (Scotland) Act, 1943. Both Schemes became operative from 5th May 1945.
