WHEREAS by Section I. of the Diplomatic Privileges (Extension) Act, 1944 (7 & 8 Geo. VI., Ch. 44), here inafter referred to as the Act, it is enacted that the provisions of that Section shall apply to any organization declared by Order in Council to be an organization of which His Majesty's Government in the United Kingdom and the Government or Governments of one or more foreign sovereign powers are members, and that His Majesty may by Order in Council provide that any such organization shall, to the extent specified in the Order, have the immunities and privileges set out in Part I. of the Schedule to the Act, and confer upon officers and servants of the organization the immunities and privileges set out in Parts II. or III of the said Schedule to the extent specified in the Order:

Now, therefore, His Majesty, by virtue and in everci.e of

Now, therefore, His Majesty, by virtue and in everci.e of the powers in this beh If by the aforesaid Act r ther vise in His Majesty vested, is pleased by and with the advice of His Privy Council to order, and it is hereby ordered. as

follows :-Article 1. The United Nat ns Organization set up by the Charter signed at San Francisco on the 26th June 1945 the Charter signed at San Francisco on the 2bth June 1945 (hereinafter referred to as the Organization), and the Pre paratory Commission of the United Nations set up by the Agreement Establishing the Commissi n signed at San Francisco on the same date (hereinafter referred to as the Pre paratory Commission) are respectively organizations of which His Majesty's Government in the United Kingdom and the Conservants of foreign soversign powers are members.

Governments of foreign sovereign powers are members.

Article 2. The Organization and, until its determination on the appointment of the Secretary General f the Organization, the Preparatory Commission, shall have the immunit es and privileges set forth in Part I. of the Schedule to the

Act.

Article 3.—(1) The persons to whom this Article applies, not being British subjects and not exceeding at any one time ten in number, shall, for the period for which their names appear as persons so entitled on the list compiled by the Secretary of State in accordance with subsection (3) of Section I. of the Act, have all the immunities and privileges specified in Part II. of the Schedule to the Act, save to the extent that the Organization or the Preparatory Commission, as the case may be, wayer any of the said immunities. sion, as the case may be, waives any of the said immunities and privileges in any given case.

(2) the persons to whom this Article applies are

(a) the Secretary-General and any Assistant Secretary

(a) the Secretary-General and any Assistant Secretary-General of the Organization and any other officer of the Organization holding a rank equivalent to Assistant Secretary-General; and
(b) pending the appointment of the Secretary-General of the Organization, the Executive Secretary and Deputy Executive Secretary of the Preparatory Commission and any other officer of the Preparatory Commission holding a rank equivalent to Deputy Executive Secretary.

Asticle 4—(1) The persons to whom this Article applies

Article 4.—(1) The persons to whom this Article applies shall have the immunities and privileges specified in paragraph 1 of Part III. of the Schedule to the Act and, if they

are nationals or citizens of, or belong to, any part of His Majesty's dominions outside the United Kingdom, those specified in paragraph 2 (a) thereof:

Provided that-

(i.) in the case of persons referred to in paragraph (2) of this Article, the Organization or the Preparatory Commission, as the case may be, may waive any immunity or privilege; and

(ii.) the exemption or relef fr m ta e and rates, e i ed in the aid paragraph 2 (a) of Par III. of the Schedule to the Act, shall not extend to any person whose usual place of abode is in the United Kingd m.

(2) This Articles applies to British subjects who hold in he Organization or in the Preparatory Commi sion, as the case may be, any of the offices referred to in Article 3 (2)

Article 5. 1) The persons to whom this Article applies shall have the immunities and privileges specified in paragraph 1 and paragraph 2 (b) of Part III. of the Schedule to the Act:

Provided that-

(i.) The Organiza ion or the Preparatory Commission, as the case may be, may waive any immunity r privilege; and

(ii.) the exemption from income tax specified n the sad paragraph 2 (b) of Part III. of the Sch d le hall not extend to any British subject whose usual place of abode is in the United Kingdom.

(a) to all officers of the Organization holding the rank of, or a rank equivalent to, Direct r, Assi tant Director, Counsellor, Principal Secretary, Assistant Principal Secretary, Secretary and Head Assistant; and,

(b) pending the appointment of the Secretary General of the Organization, to all officers of the Preparatory Commission, holding the rank of, or a rank equivalent to, Administrative Secretary, Deputy and Assistant Administrative Secretary, Chief of Section, Deputy Assistant and Associate Chief of Section.

Article 6. All officers of the Organization and, pending the appointment of the Secretary General of the Organization, of the Preparatory Commission, other than those referred to in Articles 3, 4, and 5 above, hall have the exemption from income tax specified in paragraph 2 (b) of Part III. of the Schedule to the Act:

Provided that

(i.) the Organization or the Preparatory Commission, as the case may be, may waive any privilege; and
(ii.) this privilege shall not extend to any British sub

ject whose usual place of abode is in the United Kingdom.

Article 7. This Order may be cited as "The Diplomatic Privileges (United Nations Organization and Preparatory Commission) Order in Council, 1945." It hall enter into force as from this day's date.

And the Right Honourable Ernest Bevin, His Majesty's Principal Secretary of State for Foreign Affairs, is to give the necessary directions herein.
