WHEREAS there was this day read at the Board a VV Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 17th day of June 1946 (N.8386/46), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas we have had under consideration changes

"And whereas we have had under consideration changes in the rates of pay and methods of payment of Petty Officers and Seamen of Your Majesty's Navy and non-commissioned officers and men of the Royal Marines:

"And whereas we are of opinion that future rates should include the result of the result the resu

include pay for the rank held, with increments and such other additions as may be necessary:

"We beg leave humbly to recommend that Your Majesty, by Your Order in Council, may be graciously pleased to sanction the rates of pay and conditions of payment as are set out in the accompanying Schedule, with effect from 1st July 1946.
"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.
