#### TENDERS FOR TREASURY BILLS.

.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 30th August 1946, at 1. p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, the National Loans Act, 1939, and the Miscellaneous Financial Provisions Act, 1946, to the amount of £150,000,000.

2. The Bills will be in amounts of £5000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday, the 2nd September 1946, to Saturday, the 7th September, 1946 in-clusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills re-quired are to be dated, and the net amount per cent. (being an even multiple of one penný) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England. 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

#### PAPER BOX WAGES COUNCIL (GREAT PRITAIN).

The Paper Box Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) the revocation of the Paper Box Wages Council (Great Britain) Wages Regulation Order, 1945 (S.R. & O., 1945, No. 922), and for the fixing of specified statutory minimum remuneration in substitution for the statutory minimum remuneration at present in operation, and (2) for the revocation of Order B (23) dated 25th July 1939, which relates to holidays with pay and for the making of a Wages Regulation Order in substitution for the provisions at present in operation.
