The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :--

(RECONSTRUCTION) REGULATIONS FOR FILLING TEMPORARY MACANCIES FOR ASSISTANT INSPECTORS OF ANCIENT MONU-MENTS IN THE MINISTRY OF WORKS.

1. Both men and women may compete under these Regulations.

2. Every candidate must have been born on or after 2nd

August 1910, and on or before 1st January 1924. 3. Candidates must be British subjects. They must also satisfy one of the following conditions :--

(a) If natural-born British subjects, they must either— (i.) have at least one parent who is or was at death

(1.) have at least one parent who is of this of dotting a British subject; or (ii.) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment;

(b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Candidates should have knowledge and practical experi-ence of archaeology, especially of the medieval period; pre-ference will be given to candidates with a University degree. 5. (1) Every candidate must satisfy the Commissioners as

to health and character. (2) The Commissioners reserve the right to give such preference to disabled persons or to particular classes of disabled persons as may be necessary in order to give effect to any general policy regarding the employment of such persons which may be adopted by His Majesty's Govern-ment, provided that the disability is not of a nature to interfere with the discharge of the duties.

6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course unless he or she has previously obtained permission to do so from the authority

which administers the grant. 7. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by

the Commissioners. 8. The Commissioners may summon to appear before a Selection Board all who are found to be *prima facie* eligible, or may, if they see fit, summon only those whose qualifications or may, it they see it, summon only those whose qualifications and experience are considered to be specially suitable. The Board will take into consideration the candidates' record of experience and education, with due regard to loss of oppor-tunity of knowledge of those who served in the Forces, any recommendation from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the inter-view; and on their estimation of all the above facts they will frame their recommendations. The decision of the Com-missioners shall be final missioners shall be final.

9. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department,

Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland), has been notified to the Commissioners. 10. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their Application Forms, will disqualify them for appointment. The Interviewing Board will disregard spon-taneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the University, in the Forces, or otherwise. 11. Every successful candidate shall pay a fee of £1 before the issue of a certificate of qualification for appointment.
