TEMPORARY (RECONSTRUCTION) REGULATIONS FOR FILLING VACANCIES FOR ASSISTANT ENGINEERS IN THE GENEBAL SER-VICE CLASS OF MECHANICAL AND ELECTRICAL ENGINEERS IN GOVERNMENT DEPARTMENTS.

1. Men and women may compete under these Regulations, except that women will not be eligible for appointments under

the Air Ministry. 2. Every candidate must have been born on or after 2nd August 1905 and have attained the age of 25 by the 1st

January of the year in which he or she competes. 3. Candidates must be British subjects. They must also 3. Candidates must be British subjects. satisfy one of the following conditions :--

(a) If natural-born British subjects, they must either

(i.) have at least one parent who is or was at death a British subject; or

(ii.) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment;

(b) If naturalised British subjects, they must have re-sided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of

years out of the last eight years preceding the date of their appointment. (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry,
