DIPLOMATIC PRIVILEGES (EXTENSION) ACT, 1944.

## Civil Service Commission, 17th February 1948.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :--

- ECRUITMENT UNDER NORMAL REGULATIONS OF SENIOR Geologists in the Geological Survey of Great Britain under the Department of Scientific and Industrial RECRUITMENT Research.
- 1. Age

Candidates must be at least 26 and under 31 years of age on 1st August 1948, i.e. they must have been born on or after 2nd August 1917 and on or before 1st August 1922. But a candidate who has served or is serving on a regular or short-service engagement in H.M. Forces may for this purpose deduct his period of such service from his actual age.

2. Sex and Marriage.

(i.) Both men and women may compete under these Regulations.

(ii.) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

3. Nationality.

Candidates must be British subjects. satisfy one of the following conditions :--They must also

(a) If natural-born British subjects, they must either

(i.) have at least one parent who is, or was at death, a (ii.) have at least one parent who is, or was at death, a British subject; or (ii.) have resided in His Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the

date of their appointment;

(b) If naturalized British subjects, they must have re-sided in His Majesty's dominions and or been employed
