THE Lord Lyon King of Arms has been pleased to Officially-Recognise GEORGE STILES ROME MACLACHLAN OF MACLACHLAN (formerly George Harold Stiles Rome) in the forenames George Stiles Rome and in the surname of Maclachlan of Maclachlan, which surname he has assumed on his marriage to Madam Marjorie Susan Mary Maclachlan of Maclachlan, Lady of the Barony of Strathlachlan, Representative of the Family and Head of the Clan Maclachlan, Chief of the Name and Arms of Maclachlan, whose seat is Castle Lachlan in the County of Argyll, and in whose name the Ensigns Armorial of Maclachlan of Maclachlan were matriculated in the Public Register of All Arms and Bearings in Scotland on 3rd July 1946, with provision for the bearing by courtesy of the Arms by the husbands of heritrices in the same bearing, or assuming and thereafter using, bearing and constantly retaining, the name of Maclachlan of Maclachlan and the designation Laird Baron of Strathlachlan, conform to His Lordship's Interlocutor and Warrant to the Lyon Clerk for that effect of date 22nd November 1948.
