TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 7th January 1949, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £170,000,000.

2. The Bills will be in amounts of £5000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday the 10th January 1949 to Saturday the 15th January 1949 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

GATHERING WAGES ACT, 1943.

UNLICENSED PLACE OF REFRESHMENT WAGES BOARD.

The Unlicensed Place of Refreshment Wages Board hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals (1) for the revocation of the Wages Regulation (Unlicensed Place of Refreshment) Order 1947 (Order UPR(3)), and for fixing remuneration to be paid to certain workers in substitution for the remuneration at present in operation; and (2) for the amendment of the Wages Regulation (Unlicensed Place of Refreshment (Holidays) Order, 1947, (Order UPR(4))).

Particulars of the proposals may be obtained on application to the Secretary of the Wages Board at the address given below.

The Wages Board will consider any written representations with respect to the above-mentioned proposals which may be sent to it within three weeks from 4th January 1949. Any such representation should be signed by the person making the same (adding his or her address), and sent to the

Secretary, Unlicensed Place of Refreshment Wages Board, Queen Anne's Chambers, 28 Broadway, London, S.W.1. It is desirable that persons making objections should state the precise grounds of their objections.

Civil Service Commission,

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :—

RECRUITMENT UNDER NORMAL REGULATIONS TO THE PROFESSIONAL ACCOUNTANT CLASS.

1. *Age.* Candidates must be at least 25 and under 35 years of age on 1st January 1949. But a candidate who has served or is serving on a regular (including a regular short service) engagement in H.M. Forces may for this purpose deduct the period of such service from his or her actual age.

2. *Sex and Marriage.* (i) Both men and women may compete under these Regulations, but women will not be eligible for appointment to the War Office.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

3. *Nationality.* Candidates must be British subjects. They must also satisfy one of the following conditions :—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment :

(b) if naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment ;

(c) if not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office, or Ministry of Supply unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the

pre eding paragraphs, he or she may be admitted to appointment or competition by special permission of the First Lord of the Admiralty, Secretary of State for War, or Minister of Supply, as the case may be.

4. *Qualifications.* Candidates are required to be members of one or more of the following bodies :—

- (a) Institute of Chartered Accountants in England and Wales.
- (b) Society of Incorporated Accountants and Auditors.
- (c) Society of Accountants in Edinburgh.
- (d) Institute of Accountants and Actuaries in Glasgow.
- (e) Society of Accountants in Aberdeen.
- (f) Institute of Chartered Accountants in Ireland.
- (g) Association of Certified and Corporate Accountants.

They should be capable of working without detailed supervision and are required to have had wide professional experience, including experience in :—

- (i) the preparation of financial data from detailed accounts, production and cost returns;
- (ii) financial and cost investigations;
- (iii) modern costing, wages, stores and factory control systems;
- (iv) budgetary control;
- (v) machine accounting and punched cards systems;
- (vi) the preparation of final figures and reports.

5. *Health and Character.* Successful candidates must satisfy the Commissioners as to their health and character.

6. *Competition.* The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be most suitable. The Selection Board will take into consideration the candidates' record of education and experience, any recommendations from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The decision of the Commissioners will be final.

7. *Candidates trained as Teachers.* Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland), has been notified to the Commissioners.

8. *Assignment.* The Commissioners will decide to which Department each successful candidate is to be assigned. Assignment will be made in accordance with the needs of the public service, but the wishes of candidates will be respected as far as possible.

9. *Canvasing.* Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons except as referees to be named by them in their Application Forms, will disqualify them for appointment.

10. *Fee.* Every successful candidate will be required to pay a fee of £1 before the issue of a certificate of qualification for appointment.

11. These Regulations apply only to the competition of 1949, and are liable to be modified for subsequent competitions. They are issued by the Civil Service Commissioners with the approval of the Treasury.

The maximum power authorised for use on the above-mentioned frequencies is 25 watts; but a licensee who is restricted by his licence to a maximum power of 10 watts for all frequencies must not use power in excess of 10 watts for the above-mentioned frequencies. A licensee who is restricted by his licence to the use of A1 type of emission must not use A2 and A3 types of emission on the above-mentioned frequencies.

No interference must be caused with other services operating in the bands 144-145 Mc/s; 420-460 Mc/s and 1215-1300 Mc/s; and a licensee working in these bands must immediately close down or change frequency if instructed to do so by an operator of a government station."

II.
