TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 7th January 1949, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £170,000,000

2. The Bills will be in amounts of £5000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday the 10th January 1949 to Saturday the 15th January 1949 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. 1. 5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

GATERING WAGES ACT, 1943. UNLICENSED PLACE OF REFRESHMENT WAGES BOARD.

The Unlicensed Place of Refreshment Wages Board hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals (1) for the revocation of the Wages Regulation (Unlicensed Place of Refreshment) Order 1947 (Order UPR(3)), and for fixing remuneration to be paid to certain workers in substitution for the remuneration of the proposition and (2) for the avandment of the part to certain workers in substitution for the remainera-tion at present in operation; and (2) for the amendment of the Wages Regulation (Unlicensed Place of Refreshment (Holidays) Order, 1947, (Order UPR(4)). The Wages Board will consider any written representations with respect to the above-mentioned proposals which may be sent to it within three weeks from 4th January 1949. Any such representation should be signed by the person making the same (adding his or her address), and sent to the Secretary, Unlicensed Place of Refreshment Wages Board, Queen Anne's Chambers, 28 Broadway, London, S.W.1. It is desirable that persons making objections should state the precise grounds of their objections.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H., Majesty's Treasury,

RECRUITMENT UNDER NORMAL REGULATIONS TO THE PROFESSIONAL ACCOUNTANT CLASS.

Candidates must be at least 25 and under 35 years 1. Age. of age on 1st January 1949. But a candidate who has served

of age on 1st January 1949. But a candidate who has served or is serving on a regular (including a regular short service) engagement in H.M. Forces may for this purpose deduct the period of such service from his or her actual age.

2. Sex and Marriage. (i) Both men and women may compete under these Regulations, but women will not be eligible for appointment to the War Office.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appoint not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

3. Nationality. Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either(i) have at least one parent who is or was at death a British subject; or

a British subject; or

(ii) have resided in His Majesty's dominions and/or
been employed elsewhere in the service of the Crown
for at least five years out of the last eight years preceding the date of their appointment:

(b) if naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their

appointment;

(c) if not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour. favour.

Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office, or Ministry of Supply unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the
