"And whereas we are of opinion that Marines 2nd Class (recruits) selected for training with an Army Officer Cadet Training Unit should receive pay at the rate of 5s. 0d. a day while training with the Unit.

"We beg leave humbly to recommend that Your Majesty by Your Order in Council may be graciously pleased to sanction the rate of 5s. 0d. a day to Marines 2nd Class (recruits) while under training with an Army Officer Cadet Training Unit, with effect from 18th May 1949.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."
