NOTICE TO HOLDERS OF AMATEUR WIRELESS STATION LICENCES.

The Postmaster-General hereby gives notice that licences
 granted by him for the establishment of Amateur Wireless
 Stations shall be read, construed and take effect as if the
 maximum power authorised for use on the frequencies 144 to
 146 Mc/s; 1215 to 1300 Mc/s; 2300 to 2450 Mc/s; 5650 to
 5850 Mc/s; and 10,000 to 10,500 Mc/s was 150 watts; pro-
 vided that power in excess of 10 watts may not be used on
 the above-mentioned frequencies by a licensee whose licence
 does not authorise him to use at his station power in excess
 of 10 watts for all frequencies; and that power in excess of
 25 watts may not be used on the above-mentioned frequencies

THE LONDON-EDINBURGH-THURSO TRUNK ROAD (BUNCHREW STATION AND OTHER DIVERSIONS) ORDER, 1949.

 Act, 1946, as so amended, has not been complied with in
 relation to the Order, may, within six weeks of the twenty-
 first day of October 1949, apply to the Court of Session for
 the suspension or quashing of the Order or of any provision
 contained therein.
