The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Com-missioners of the Admiralty, dated the 8th day of December 1949 (N.L. 7066/48), in the words following, viz. :--"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all Pay, Wages, Pensions, Bounty Money, Grants, or other Allowances in the nature thereof, payable in respect of service in Your Majesty's Naval or Royal Marine Force to a person being or having been an Officer, Seaman, or Marine, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are, from time to time, directed by Order in provisions as are, from time to time, directed by Order in Council :

And whereas with a view to the avoidance of public loss we consider it desirable that in cases where a person having

we consider it desirable that in cases where a person having been in Your Majesty's Naval or Marine Forces owes a judg-ment debt to the Crown, we should have power to effect recovery of such debt by deductions from any Half-pay, Retired Pay, Pension, or other Allowance in the nature thereof payable to that person : "We therefore beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to direct that any Half-pay, Retired Pay, Pension, or other Allowance in the nature thereof payable to any person having been an Officer, Seaman, or Marine of Your Majesty's Naval or Marine Forces shall be liable to deductions of such amounts and at such times and for such periods as we in our direction or Marine Forces shall be liable to deductions of such amounts and at such times and for such periods as we in our direction think fit for the purpose of effecting the recovery in whole or in part of the amount of any judgment debt owing to the Crown by any such person as aforesaid. "The Lords Commissioners of Your Majesty's Treasury have expressed their concurrence in this proposal." His Majesty, having taken the said Memorial into con-sideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.
