DEPARTMENT OF HEALTH FOR SCOTLAND.

PUBLIC HEALTH (IMPORTED FOOD) (SCOTLAND) REGULATIONS, 1937 TO 1948.

The Secretary of State for Scotland gives notice, in pursuance of the above-named Regulations, that he hereby recognizes the Official Certificate, of which particulars are given in the Schedule hereto, as showing (a) that the meat to which it relates was derived from animals inspected ante- and post-mortem and passed in accordance with criteria satisfactory to the Secretary of State, and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat.

The Certificate being in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat.

The stamp hereby recognized may be used as an alternative to the label reproduced in Part I of the Schedule to the Notice published in the Edinburgh Gazette of the 5th April 1938.

WATER (SCOTLAND) ACTS, 1946 AND 1949.
ARBROATH CORPORATION (WATER—ADDITIONAL WORKS) ORDER, 1950.

NOTICE is hereby given, in terms of paragraph 3 of Part I of the First Schedule to the above Act of 1946, that the Provost, Magistrates, and Councillors of the Royal Burgh of Arbroath or Arbroath (hereinafter referred to as "the Corporation") have submitted to the Secretary of State draft of an Order which they desire him to make under the powers conferred on him by Sections 21, 42, and 88 of the Water (Scotland) Act, 1946.

The Order would enable the Corporation to increase the statutory amount of water which the Corporation are authorised to take from the waters of the stream called the Noran Water and to extract such amount from the Glenogil Reservoir to vary the statutory amount of compensation water to be discharged therefrom and to construct and maintain water works including valve towers, measuring weirs, measuring houses, trunk mains, aqueducts, and ancillary works.
