DISCIPLINARY REGULATIONS

SECTION 13 OF THE Regulations made in pursuance of Section 13 of the Architects (Registration) Act, 1931, . amending the Existing Disciplinary Regulations.

Regulation 2. Delete Disciplinary Regulation 2 and substitute the following :--

2. If it shall appear to the Council that the affidavit discloses a prima facie case against the registered person the Council shall, if it appears to them to be necessary, direct the Discipline Committee to hold an enquiry into the case in accordance with Section 7 of the Act and the Regulations following, and the Clerk shall forthwith cause to be served on the approximation of the applicant of the served following, and the Clerk shall forthwith cause to be served on the registered person and on the applicant a notice as to time and place of such enquiry in accordance with Section 7 (4) of the Act. Such notice shall not be less than a twenty one day notice. The notice may be in the forms set out in the Schedule and shall require the applicant and the registered person respectively to furnish to the Clerk of the Discipline Committee and to each other a list of all documents on which they representingly propose to rolu such list chell unless other they respectively propose to rely, such list shall unless other wise ordered by the Discipline Committee be furnished by the applicant and by the registered person respectively at least 14 days before the date of hearing. The Clerk shall with such notice serve on the registered person a copy of the application and off douit application and affidavit.

Regulation 3. Delete Disciplinary Regulation 3 and substitute the following :--

3. The Clerk in serving notice on the registered person in The clerk in serving notice on the registered person in respect of whom the inquiry has been ordered shall inquire whether he is a member of any of the bodies referred to in the first schedule of the Act and shall inform the body of which that person is a member, except where the Discipline Committee already include a member of that body, that they are activated to remain the answer for membership of the are entitled to nominate one person for membership of the Discipline Committee by notice in writing sent by post in a registered letter to the Clerk and the person so nominated shall from the date of the notice be deemed to be a member of the Discipline Committee for the purpose of the particular inquiry and of the report in connection with the member of the Body by which the additional member has been nominated

and the appointment of such additional member shall be confirmed by the Council.

Regulation 8. Insert the following new Disciplinary Regulations 8 (a) and 8 (b) :---

The Discipline Committee in their discretion may 8 (a). accept evidence given by affidavit in corroboration f ral

testimony. 8 (b). The Discipline Committee in their discretin may accept letters and other documents as prima facte eviden without formal proof of signature or receipt thereof

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz. :--

RECRUITMENT UNDER NORMAL REGULATIONS TO THE PSYCHOLOGIST CLASS.

1. Age.

(i) Candidates for appointments as Psychologist must be at least 21 and under 31 years of age on 1st May 1950. But a candidate who has served or is serving on a regular (including a regular short service) engagement in H.M. Forces may for this purpose deduct the period of such

Forces may for this purpose deduct the period of such service from his actual age. (ii) Candidates for appointment as Senior Psychologist, Principal Psychologist, or Senior Principal Psychologist must be at least 31 years of age on 1st May 1950. The Commissioners have not specified an upper age limit for these grades; in general, however, Government Depart-ments require a reasonable period of service from persons newly appointed to the Civil Service, and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates who are over 50 years of factor in considering candidates who are over 50 years of age.

2. Sex and Marriage.

(i) Both men and women may compete under these Regulations, except that women will not be assigned to the Admiralty.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than civil servants and nave drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of re-covery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity naid the marriage gratuity paid.

3. Nationality. Candidates must be British subje They must also satisfy one of the following conditions :subjects.

(a) If natural-born British subjects, they must either :---(i) have at least one parent who is or was at death a

British subject; or (ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

Provided that a candidate will not be eligible for an ap-pointment under the Admiralty or Air Ministry unless he is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents

also born within the United Kingdom or in one of the self governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he may be admitted to appoint ment or competition by special permission of the First Lord of the Admiralty or Secretary of State for Air as the case may be.

4. Qualifications.

(1) Candidates must have professional qualifications or experience in Psychology as stated below :---

(a) A first or second Class Honours degree of a recog nized University in which Psychology was taken as a main subject. (b) A Higher degree in Psychology. (c) A Bachelor of Education degree of a Scottish

University.

(d) A post graduate diploma in Psychology, following at least two years' systematic study.
(e) Fellowship of the British Psychological Society.
(f) Associateship of the British Psychological Society,

provided that the applicant

(i) has obtained a first or second Class Honours degree of a recognized University in a subject other than Psychology; and (ii) has for not less than three years been responsible for work in Psychology or its applications which in

the opinion of the Council is evidence of an adequate knowledge of Psychology; and (iii) was elected as an Associate of the Society after

1943.

Candidates taking the Final examinations under (a), (b), (c), (d) above in Summer 1950 may compete, but they will not be offered appointment unless they obtained the qualification concerned by 31st August 1950.

(2) In exceptional cases candidates who do not possess any of the above qualifications may be accepted by the Commissioners at their discretion if they have at least three years' responsible professional experience.

5. Health and Character. Successful candidates must satisfy the Commissioners as to their health and character.

6. Competition. The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be most suitable. The Selection Board will take into con sideration the candidates' record of education and experience our recommendations from correspondent by the candidates any recommendations from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The Selection Board will recommend for appointment to a particular grade those candidates who are eligible for more than one grade. The decision of the Commissioners will be final.

7. Candidates Trained as Teachers. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland), has been notified to the Commissioners.

8. Assignment. The Commissioners will decide to which Department each successful candidate is to be assigned. Assignment will be made in accordance with the needs of the public service, but the wishes of candidates will be respected as far as possible.

9. Canvassing. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their Application Forms, will disqualify them for appointment.

10. Fee. Every successful candidate will be required to pay a fee of $\pounds 1$ 10s. Od. before the issue of a certificate of qualification for appointment.
