The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz. :---

RECULATIONS FOR THE RECRUITMENT OF MUSEUM ASSISTANTS IN THE SCIENCE MUSEUM UNDER THE MINISTRY OF EDUCATION.

1. Sex and Marriage.

(i) Both men and women may compete under these regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their hus-bands, or whose husbands suffer without hope of recovery from total mental or physical incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

2. Age.

Candidates must be at least 16 and under 25 years of age on the 1st January of the year in which the competition is held. But

(a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age

(b) a candidate who has served or is serving in H.M. Forces otherwise than on a regular or short-service engage-ment, may deduct the period of such service from his actual age, up to a maximum of two years;

(c) candidates who have served in any established post to which they were admitted with the Certificate of the Civil Service Commissioners, or who have served on estab-

lished conditions except for sick leave and pension in a post to which such a Certificate would normally apply, may deduct from their actual age any time not exceeding two years which they may have spent in such service.

3. Nationality.

Candidates must be British subjects. satisfy one of the following conditions :--They must also

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a

British subject; or (ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Grown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalized British subjects they must have re-sided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualifications.

Candidates must satisfy the Civil Service Commissioners that they have received such systematic education as in the Commissioners' opinion fits them for appointment.

Candidates must

(a) have obtained School Certificate with a credit in mathematics or a science subject, or for the Science Library in a modern foreign language, or have passed an examina-tion of equivalent or higher standard; or

(b) produce a statement from the Scottish Education Department or the Ministry of Education for Northern Ireland showing that they have attained a standard equivalent to that of the Schools Certificate of the Oxford and Cambridge Schools Examination Board, including the special qualification in mathematics, a science subject or a modern foreign language; or

(c) have passed (i) the Forces Preliminary examination, (ii) the Royal Air Force Higher Education Test, Part I, or (iii) the Admiralty Higher Education Test, Second Class; in all cases with a pass in mathematics or a science subject or a modern foreign language.

The above requirements may be waived exceptionally in the case of candidates with experience of value to the Museum who can produce evidence from a responsible person or body under whom they have worked that they have reached at least an equivalent standard of knowledge in their particular subject.

5. Experience.

Candidates for appointment direct to the established grade in the Museum Departments must have had thorough outside experience gained by service in a Government Department or experience gained by service in a Government Department of other civilian scientific or engineering establishment or in technical branches of the Forces. The experience must cover a minimum period of two years, to be completed before 22nd February 1951, on duties appropriate to the scientific subjects covered by the Museum Departments.

Candidates for appointment direct to the established grade in the Science Library must have had thorough outside ex-perience of general library technique gained by at least two years' service completed before 22nd February 1951 in a Government or public library or the library of an engineering or scientific establishment.

6. Competition.

6. Competition. Those candidates who appear from their application forms to have the best qualifications will be summoned to appear before a Selection Board in London which will recommend to the Commissioners for appointment in an established or an unestablished capacity, the candidates who appear to be most suitable. The Board will take into consideration the candi-dates' record of education and experience, any recommenda-tion that they may receive from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview, and on their estimation of the above evidence they will frame their recommendations. The decision of the Commissioners will be final.

7. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

8. Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

9. Canvassing.

Any attempt on the part of candidates to enlist support for their application through Members of Parliament or other influential persons (except as referees to be named by them in their application form) will disqualify them for appoint-ment. The Selection Board will disregard recommendations from persons who are not personally acquainted with the candidate's work.

10. Appointment.

10. Appointment. Successful candidates aged 18 or over who possess the necessary experience (see paragraph 5 above) will enter the grade in an established capacity. Other successful candidates will enter in an unestablished capacity in the first instance, and will be considered for established appointment after such period of training as may be necessary in each case. When the training period exceeds two years, the Commissioners may require the officer to satisfy a second Interview Board set up by them at the end of his training.

of his training. Appointment to the established staff will be conditional upon the issue of the Commissioners' certificate of qualification.

11. Fee.

A successful candidate for established appointment will be required to pay a fee of 12s. 6d. before the issue of a certificate of qualification.
