REGULATIONS FOR THE NORMAL RECRUITMENT FROM ESTAB-LISHED CLERICAL OFFICERS FOR THE EXECUTIVE CLASS (AND CORRESPONDING DEPARTMENTAL CLASSES) AND INFORMATION OFFICER CLASS OF THE HOME CIVIL SERVICE.

Age.

Candidates must be at least 21 and under 28 years of age

Candidates must be at least 21 and under 28 years of age on the 1st August 1951.

Provided that the Commissioners may, at their discretion, waive the maximum age limit in favour of a candidate who has been employed by his Department overseas, if they are satisfied that he would otherwise be deprived of one of the attempts which, but for service overseas, he might have made while within the normal age limits.

4. Number of Attempts.

6. Examination.

The written examination will consist of papers in English and Arithmetic, a General Paper, and a test of General Intelligence.

Of the candidates who obtain the highest marks in the written examination a certain number, to be fixed by the Commissioners, will be summoned to an interview at which the Interviewing Board will award each candidate a mark for his or her record and personal qualities. The Department of each candidate summoned to interview will be asked to supply a confidential report and this will be taken into account by the Interviewing Board.

The final order of merit will be determined by combining the marks for written examination and interview.

The Commissioners will decide to which Department each successful candidate is to be assigned. A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment. Assignments will be made in accordance with the needs of the public service, but regard will be paid, so far as vacancies permit, to the previous Departmental experience of the candidates and to the wishes of Departments

RECRUITMENT UNDER NORMAL REGULATIONS OF A FISHERY OFFICER (MALE) IN THE MINISTRY OF AGRICULTURE AND FISHERIES.

Candidates must be at least 23 years of age on the 1st January 1951. The Commissioners have not specified an upper age limit for this Competition; in general, however, Government Departments require a reasonable period of service from persons newly appointed to the Civil Service, and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates for this post who are over 50 years of age.

Men only may compete under these Regulations.

Candidates must be British subjects. satisfy one of the following conditions:— They must also

- (a) If natural-born British subjects, they must either

(i) have at least one parent who is, or was at death, a British subject; or

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualification.

A candidate must satisfy the Commissioners that he possesses a sound general education and is qualified to deal with matters affecting fishermen and the fishing industry. For this purpose some knowledge of sea fisheries and of the fishing industry or some seafaring experience is desirable.

5. Health and Character.

The successful candidate must satisfy the Commissioners as to his health and character.

6. Competition.

The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be most suitable. BEAULY/SHIN TRANSMISSION LINES.

THE North of Scotland Hydro-Electric Board have prepared a Constructional Scheme in accordance with Section 5 of the Hydro-Electric Development (Scotland) Act, 1943, as amended by the Electricity Act, 1947, providing for the construction of Works, the situation of which is shown in Part I of the Schedule hereto, and for the acquisition of the Lands and Wayleaves specified in Part II of the said Schedule Schedule.

The Scheme has been approved by the British Electricity Authority and submitted to the Secretary of State for confirmation.
