The Secretary of State for Scotland, in exercise of his powers under the Seeds Act, 1920, has made the Seeds (Scotland) Amendment Regulations, 1951, with effect as from

1st August 1951.

Under the Seeds Act, 1920, a seller of seeds must declare certain prescribed particulars, which include particulars with respect to the percentage of purity (i.e., the percentage of seeds which are of the kind of which the parcel purports to consist), ascertained on a test made in accordance with the provisions of the Act. These Regulations amend the Seeds (Scotland) Regulations, 1922, so that the method prescribed for determining in Scotland the percentage of purity may conform with the present practice of international trade in seeds. Under the Seeds Act, 1920, a seller of seeds must declare seeds.

A candidate must offer the four compulsory subjects (1) to (4) and any two subjects chosen from the optional subjects (5) to (10). Every candidate must attain in each subject he offers and in the examination as a whole such a standard as to satisfy the Civil Service Commissioners.

Of those who obtain the highest aggregate marks in the Written Examination a certain number to be determined by the Commissioners will be admitted to Part II of the examination. The order of merit of the candidates will be determined by the aggregate marks in the whole examination.
