TREASURY MINUTE DATED 31ST DECEMBER 1951, SUPPLEMEN-TARY TO THAT DATED 8TH NOVEMBER 1951, PRESCRIBING THE TERMS UPON WHICH THE REPAYMENT OF LOANS MADE FROM THE LECAL LOANS FUND BEFORE 1ST AUGUST 1945, MAY BE ALLOWLD IN MOVANCE OF THE DUE DATE. My Lorde read Treasury Minute of 8th November 1951, prescribing the terms upon which, on and after 10th November 1951, repayments in respect of loans advanced from the Local Loans Fund before 1st August 1945, may be accepted in advance of the due date, and, in particular, the provision provision

that the borrower repays a sum equal to the present that the borrower repays a sum equal to the present value of the annuity payments (or payments of equal instalments of principal with diminishing interest) still remaining to be made to the Public Works Loan Com-missioners under the mortgage with those Commissioners, such present value being calculated by discounting the annuity payments (or other annual or half-yearly payments) at a rate of 3¹/₂ per cent.

For the purpose of removal of doubt, My Lords authorize and require that the above provision shall always be subject to the condition that the minimum sum to be repaid in respect of each $\pounds 100$ of principal outstanding shall be $\pounds 100$ cash.

(TERENCE O'NEILL FRASER KELLY.)

Whereas Terence O'Neil Fraser Kelly, M.B., Ch.B., whose registered address is 185 Westburn Road, Aberdeen, has been convicted of offences against the Dangerous Drugs Acts, 1920 to 1932 :

And whereas the said Tenence O'Neil Fraser Kelly cannot, in my opinion, properly be allowed to be in possession of or to supply any drug or preparation to which the Dangerous Drugs Regulations, 1937, or any drug to which the Raw Opium, etc., Regulations, 1937, apply: Now therefore, in pursuance of the powers conferred on me by Regulation 7 of the Dangerous Drugs Regulations, 1937, and by Regulation 5 of the Raw Opium, etc., Regula-tions, 1937, I hereby withdraw from the said Terence O'Neil Fraser Kelly the authorities conferred by the said Regulations upon him to be in possession of and to apply O'Neil Fraser Kelly the authorities conferred by the said Regulations upon him to be in possession of and to supply the drugs or preparations to which the Dangerous Drugs Regulations, 1937, and the drugs to which the Raw Opium, etc., Regulations, 1937, apply : And I hereby direct that it shall not be lawful for the said Terence O'Neil Fraser Kelly to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz. :--

RECRUITMENT UNDER NORMAL REGULATIONS OF ASSISTANTS (SCIENTIFIC) IN VARIOUS GOVERNMENT DEPARTMENTS.

1. Age.

Candidates must be at least $17\frac{1}{2}$ and under 26 years of age on 1st January 1952. But

(a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from

H.M. Forces may deduct the period of such service from his actual age; (b) for a certain number of vacancies, candidates bern on or before 1st January 1926, whe have specialised ex-perience may be admitted. No upper age limit is specified for such candidates; in general, however, Government Departments requires a reasonable period of service from persons newly appointed to the Civil Service, and accord-ingly the Commissioners reserve the right to give weight to this factor in considering candidates who are over 50 years of age.

2. Sex and Marriage. -

(i) Both men and women may compete under faces Regulations.

(ii) Married women who have formerly been established Civil Servants and have drawn marriage gratuity (other

than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appoint-ment the marriage gratuity paid.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions :-

(a) If natural born British subjects, they must either (i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preced-ing the date of their appointment. (b) If naturalized British subjects, they must have

resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of

years out of the last eight years preceding the date of their appointment. (c) If not q alified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their formation favour.

ravour. Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office, Air Ministry, or Ministry of Supply, unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by Justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he or she may be admitted to competition or appointment by special permission of the First Lord of the Admiralty, Secretary of State for War, Secretary of State for Air, or Minister of Supply, as the case may be.

4. Educational Qualifications.

Every candidate must, on the date he sends in his applicabe in possession of one of the under-mentioned tion. qualifications :-

(a) A School Certificate with credit in mathematics or a science subject obtained by passing one of the following examinations :-

The School Certificate Examination of the Oxford and

Cambridge Schools Examination Board. The School Certificate Examination of the Oxford Delegacy for Local Examinations.

The School Certificate Examination of the Cambridge Local Examinations Syndicate.

The School Certificate Examination of the University of Bristol. The School Certificate Examination of the University

of Durham.

The General School Examination of the University of London

The School Certificate Examination of the Northern Universities Joint Matriculation Board.

The School Certificate Examination of the Central Welsh Board.

In place of a School Certificate a candidate may produce evidence of having passed the Matriculation Examination of London University or any other examination which in the opinion of the Civil Service Commissioners is of equivalent or higher standard, or

(b) A General Certificate of Education in four subjects at Ordinary level to include (a) English Language, and

(b) a scientific or a mathematical subject, or (c) The Senior Leaving Certificate of the Scottish Education Department which includes a pass on at least the lower grade in the special subject of mathematics or science, or

(d) A statement from the Scottish Education Depart-nent or the Ministry of Education for Northern Ireland showing that the candidate has attained a standard equivalent to that represented by the award of the School Certificate of the Oxford and Cambridge Schools Examination Board, including the special qualification in mathe-matics or a science subject, or by the General Certificate of Education in four subjects at Ordinary level including English Language and a scientific or mathematical subject, or

(e) The Ordinary National Certificate;

(The Commissioners may admit as eligible under this paragraph candidates who have satisfactorily completed the second year (s. 2) of the Senior course), or (f) The Intermediate Examination of the Institute of

Medical Laboratory Technology, or

(g) An Intermediate Grouped Course Certificate of the City and Guilds of London Institute in relevant subjects (e.g., The Laboratory Technicians Intermediate Certificate), or

(h) A pass in either the Forces Preliminary Examination with a pass in either mathematics or natural science, or

the Royal Air Force Higher Education Test, Part I, with a pass in mathematics, mechanics or the properties of matter, or

the Admiralty Higher Educational Test, Second Class, with a pass in mathematics or mechanics or magnetism

and electricity, but (j) The Commissioners may also accept as eligible candidates who are unable to comply with the requirements above, but who

(i) produce evidence satisfactory to the Commissioners that they have reached School Certificate Credit standard

in Mathematics or a Science subject, or the equivalent in the General Cetrificate of Education or (ii) have served for at least 10 years, on a regular (including a regular short-service) engagement, in the technical branch of H.M. Forces. Such candidates must have served an artificer apprenticeship where appro-priate) or have reached the rank of Petty Officer, or Sergeant, or

(iii) are employed full-time as glass-blowers in Govern-ment Departments, provided they are nominated by their Department and satisfy the Commissioners of their skill in their craft. Such candidates must be wholly em-ployed in the construction of glassware for use in scientific laboratories scientific laboratories.

5. Experience:

Every candidate must have had thorough experience in the duties of the class gained by service in a Government Department or other civilian scientific establishment or in technical branches of the Forces. The experience must cover a minimum period of two years to be completed before the date on which he sends in his application, on duties appro-priate to the type of vacancy for which application is made and the two-year period must be recent, subject to allowance for gaps in cases where the experience has been broken by for gaps in cases where service in H.M. Forces.

6. Comnetition.

(i) The Commissioners may, at their discretion, summon candidates to preliminary informal interview.

(ii) The Commissioners may, at their discretion, impose a practical or other relevant test upon candidates, or groups of candidates, as seems appropriate

(iii) Those candidates whose qualifications and experience seem most suitable will be summoned to appear before a Selection Board appointed by the Commissioners. The Board will take into consideration the candidates' record of Board will take into consideration the candidates' record of education and experience, any recommendations that they may receive from persons named by the candidates as having direct knowledge of their work in the past, and the candidates' scientific knowledge and personal qualities as shown at the preliminary interview, the practical or other test imposed, and at the final interview; and on their estima-tion of all the above evidence the Board will frame their tion of all the above evidence the Board will frame their recommendations.

(iv) The decision of the Commissioners will be final.

7. A candidate may make one and only one application under these Regulations.

8. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

9. Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Depart-ment, the Ministry of Education for Northern Ireland), has been notified to the Commissioners.

10. Assignment.

It will rest with the Commissioners to determine the Department to which each successful candidate shall be assigned. In making the assignments the Commissioners will be guided by the requirements of the public service but the wishes of candidates will be met as far as possible.

11 Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons except as referees to be named by them in their Application Forms, will disqualify them for appointment.

12 Fee.

Every successful candidate will be required to pay a fee of 12s. 6d. before the issue of a certificate of qualification for appointment.
