## TRUNK ROADS ACT, 1946.

## SPECIAL ROADS ACT, 1949.

The Minister of Transport hereby gives notice that he has made an Order under sub section 2 of Section 1 of the Trunk Roads Act, 1946, as amended by the Special Roads Act, 1949, the effect of which is that a By-Pass which he proposes to construct at Upper Largo in the County of Fife will become a trunk road on the date when the Order comes into operation and the length of the Dennyloanhead-Kircardine Kirkcaldy-St. Andrews Trunk Road to be superseded thereby will cease to be a trunk road on the date on which notice is given by the Minister to the Fife County Council (who will thereafter become the highway authority responsible for that road) that the By-Pass is opened for through traffic.

Copies of the Order and of the plan referred to therein have been deposited at the Ministry of Transport, Berkeley Square House, London, W.1, and at the offices of the Fife County Council, County Buildings, Cupar, Fife, and may be seen at all reasonable hours.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Trunk Roads Act, 1946, as amended by the Special Roads Act, 1949, or on the ground that any requirement of the Trunk Roads Act, 1946, as so amended has not been complied with in relation to the Order, may, within six weeks of the fourth day of January 1952, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.
