TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 9th May 1952, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.

2. The Bills will be in amounts of £5000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday, the 12th May 1952 to Saturday the 17th May 1952, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz. :—

RECONSTRUCTION COMPETITION FOR THE APPOINTMENT OF ILLUSTRATORS IN VARIOUS GOVERNMENT DEPARTMENTS.

1. Age.

Candidates must be at least 21 and under 47 years of age on 1st January 1952, i.e., they must have been born on or after 2nd January 1905 and on or before 1st January 1931.

But a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age.

2. Sex.

Both men and women may compete under these Regulations.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either
(i) have at least one parent who is, or was at death, a British subject; or

(ii) have resided in Her Majesty's Dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalized British subjects, they must have resided in Her Majesty's Dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's Dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

Provided that a candidate will not be eligible for appointment to the Admiralty, or Ministry of Supply unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions, of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he or she may be admitted to competition or

appointment by special permission of the First Lord of the Admiralty, or Minister of Supply, as the case may be.

4. Qualifications.

Candidates must have had at least five years' training and experience of illustrative work. This must consist of at least one year on practical art work in the Civil Service or outside industry or a combination of the two; the remainder of the five years must have been spent in one or more of the following ways:—

(a) Full-time employment on practical art work in the Civil Service.

(b) Full-time employment on practical art work in outside industry.

(c) Full-time training at a recognized art school.

5. Health and Character.

Every successful candidate must satisfy the Commissioners as to his or her health and character.

6. Competition.

The Commissioners may summon to appear before a Selection Board all who are found to be *prima facie* eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be specially suitable for the posts for which they are being considered. The Board will take into consideration the candidates' record of education, experience, and certified samples of their work which they will be asked to bring with them, any recommendation from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The decision of the Civil Service Commissioners shall be final.

7. Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

8. Assignment.

Candidates will be required to state on their application forms for which Department or Departments they are competing. In the case of candidates who are declared successful for more than one Department, it will rest with the Commissioners to determine the Department to which they shall be assigned, due regard being paid, as far as possible, to the preference of the candidates.

9. Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, or other educational institution, in the Forces, or otherwise.

10. Fee.

A successful candidate shall be required to pay a fee of 12s. 6d. before the issue of a certificate of qualification for appointment.

DISEASES OF ANIMALS ACT, 1950.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 62, 1952. (Made 27th April 1952.)

1. Declares an area comprising the districts situate within approximately 15 miles of Netherhills, Fisherie, King Edward, Aberdeenshire, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Aberdeen and Banff.

2. Extends the Foot-and-Mouth Disease Infected Area around Sparsholt, Wantage, Berkshire, declared by Special Order No. 61, 1952, so as to include the parishes of Gosford and Water Eaton, Bladon, Yarnton, Begbroke and Kidlington.

BURGH OF NORTH BERWICK.

NOTICE is hereby given that the Provost, Magistrates, and Councillors of the Burgh of North Berwick have presented an Initial Writ to the Sheriff of the Lothians and Peebles at Haddington under the Local Government (Scotland) Act, 1947, to revise, alter, and extend for the purposes of the said Act the boundaries of the said Burgh.
