WHEREAS the Secretary of State for Scotland has, in WHEREAS the Secretary of State for Scotland has, in pursuance of the powers competent to him under Section 5 of the Burial Grounds (Scotland) Act, 1855 (18 & 19 Vict., c. 68), made a Representation that he has received a copy of an Interlocutor dated 14th July 1952 pronounced by the Sheriff-Substitute of Perth and Angus at Perth, finding that (1) the Churchyard or Burial Ground known as the Old Churchyard in the Village and Parish of Methven, and (2) the Churchyard or Burial Ground known as Arngask in the Village of Glenfarg and Parish of Arngask, both in the County of Perth, are both in a condition which is dangerous to health and are overcrowded : And whereas in the said Representation it is recommended that, in terms of Section 5 of the said Act burials be forth-with discontinued in the said Burial Grounds subject to the exceptions hereinafter mentioned : And whereas by an Order in Council of the 21st day of October 1952, Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 12th day of December 1952, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice should be fixed on the doors of the churches of or on some other conspicuous places within the Parishes of Methven and Arngesk one moth

should be published in the Edinburgh Gazette, and that copies of the said Order or Notice should be fixed on the doors of the churches of or on some other conspicuous places within the Parishes of Methven and Arngask one month before the said 12th day of December 1952 : And whereas Notice of the said Representation and of the time when it pleased Her Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council : Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, as follows:— 1. That, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the Churchyards or Burial Grounds known as the Old Church-yard in the Village and Parish of Methven and the Church-yard and Burial Ground known as Arngask in the Village of Glenfarg and Parish of Arngask both in the County of Perth except for the burial of :— (1) a person in that Burial Ground in which his or her

(1) a person in that Burial Ground in which his or her

(1) a person in that Burial Ground in which his or her spouse was buried, prior to the date of closure;
(2) a parent in that Burial Ground in which his or her child or children were buried prior to the date of closure;
(3) an unmarried person in that Burial Ground in which one or both of his or her parents or one or more bothers or sisters of his or hers are buried prior to the date of

(4) any person whom the County Council of Perth may specially authorize to be buried in one or other of the said Burial Grounds; (5) cremated human remains :

Provided that the exercise of the right of burial be not injurious to health or offensive or contrary to decency;

that intimation of a burial be given to the Sanitary In spector for the County of Perth not later than the day preceding that on which a grave is to be opened; tha no burial except the burial of cremated human remain shall be made unless there is a lair in the family ground available for use at the time required; unless the grav is at least 5 feet deep and burial can be made withou interferen e with the remains of a previous burial; and unless it is at least 20 years since the immediatel preceding b trial in the same lair.

2. This Order may be cited as the Burial Grounds (Scotland) (Parish of Methven Old Churchyard and Parish of Arngask (Glenfarg) Churchyard) Order, 1952.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasun hereby give notice that Tenders will be received at the Chi Cashier's Office, at the Bank of England, on Friday th 2nd January 1953, at 1 p.m., for Treasury Bills to be issue under the Treasury Bills Act, 1877, the National Debt Ac 1889, and the National Loans Act, 1939, to the amount o £180,000,000.

2180,000,000. 2. The Bills will be in amounts of £5000, £10,000, £25,000 £50,000, or £100,000. They will be dated at the option o the Tenderer on any business day from Monday the 5t January 1953 to Saturday the 10th January 1953. inclusiv and will be due 91 days after date. 3. The Bills will be issued and paid at the Bank of Forland

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

different dates. 5. Tenders must be made through a London Banker, Discount House, or Broker. 6. Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 pm. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated. 7. Members of the House of Commons are not precluded from tendering for these Bills.

from tendering for these Bills. 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
