1. That in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the Burial Ground at Clachan Sand, North Uist, in the County of Inverness, except for the burial of :—

- any person whom the County Council of Inverness may specially authorise to be buried in the said Burial Ground;
- (2) cremated human remains:

Provided that the exercise of the right of burial be not Injurious to health or offensive or contrary to decency; that inimitation of a burial be given to the District Sanitary Inspector of the County of Inverness not later than the day preceding that on which a grave is to be opened; that no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin, and that without interference with the remains of a previous burial.

2. This Order may be cited as the Burial Grounds (Scot-land) (Parish of Clachan Sand Old Burial Ground) Order, 1953.

Provided that the exercise of the right of burial be not Provided that the exercise of the right of burial be not injurious to health or offensive or contrary to decency; that intimation of a burial be given to the District Sanitary Inspector of the County of Inverness not later than the day preceding that on which a grave is to be opened; that no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin, and that without interference with the remains of a previous burial.

2. This Order may be cited as the Burial Grounds (Scot-land) (Parish of Kilmuir Old Burial Ground) Order, 1953.

The Secretary of State for Scotland, in exercise of his powers under the Destructive Insects and Pests Acts, 1877 (Amendment) Order, 1953, which came into operation on 5th February.

This Order extends to tulips, hyacinths, gladioli, irises, and crocuses the provisions of the Sale of Diseased Plants (Scotland) Orders of 1936 to 1944, which prohibit the sale for planting of any plants substantially affected by pests or diseases, authorise Inspectors to enter premises and examine plants under the Orders and provide for the service of notices ordering the destruction or treatment of affected plants.

IMPORTATION OF PLANTS

The Secretary of State for Scotland has made The Importation of Plants (Scotland) Amendment Order, 1953, which came into operation on 5th February 1953.

which came into operation on 5th February 1953. This Order provides for the amendment of the form of certificate of health accompanying living plants landed in Scotland from abroad consequent upon the alteration, by the Importation of Forest Trees (Prohibition) Order, 1952, of the kinds of trees which may not be imported except under licence, viz. (a) from any European country, any plants of the genera Castenea, Populus, or Quercus, or of the genera of the Order Pinacae, viz. Abies, Larix, Picea, Pinus, Pseudotsuga, Sequoia, Thuja, and Tsuga; (b) from any country outside Europe, any plants of the genera listed above, with the addition of any plants of the genus Ulmus.

MARKING OF IMPORTED WOODEN DOWELS AND DOWELLING

In accordance with the provisions of Sub-section 4 of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade announce that in pursuance of an application re-ceived by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin they have made a reference to the Standing Committee appointed by the Board of Trade under the Act in respect of the following classes and descriptions of imported goods:—

Wooden dowels and dowelling, including cylindrical pieces of timber, grooved or otherwise, not exceeding 10 feet in length and not exceeding one inch in diameter, howsoever described or for whatsoever purpose to be used, Attention is called to the fact that, whilst, under the pro-

visions of the Act, the Committee must in every case referred to them consider whether the goods should bear an india-tion of origin at the time of sale or exposure for sale, they have discretion also to consider and report whether such goods should bear an indication of origin at the time of importation.
