EXPLANATORY NOTE

These Regulations amend the National Insurance (Widow's Benefit and Retirement) Regulations, 1948, by further relaxing for the purposes of widow's pensions the condition as to the duration of marriage in the case of widows married more than once. They provide that, in certain circumstances, such a widow may, in computing the duration of her last marriage, include any period during which sha use entitled to a widow's pension and an addiwhich she was entitled to a widow's pension and an addi-tional allowance under the Widows', Orphans', and Old Age Contributory Pensions Acts, 1936 to 1941.
