RUBBER MANUFACTURING WAGES COUNCIL (GREAT BRITAIN)

THE Rubber Manufacturing Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for increases in statutory minimum remuneration by the amendment of the Rubber Manufacturing Wages Council (Great Britain) Wages Regulation Order, 1952 (Order R.U. (38)), as amended by the Rubber Manufacturing Wages Council (Great Britain) Wages Regulation (Amendment) Order, 1954 (Order R.U. (40)) and for the revocation of Order R.U. (40).

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within fourteen days from 25th February 1955. STATUTORY INSTRUMENTS 1955 No. 274 **FACTORIES**

THE EMPLOYMENT OF YOUNG PERSONS (GLASS **CONTAINERS) REGULATIONS, 1955**

Made 15th February 1955 21st February 1955 Laid before Parliament Coming into Operation 1st March 1955

THE Minster of Labour and National Service, by virtue of the powers conferred on him by Section 81 of the Factories Act, 1937 (a) (hereinafter referred to as "the Act") and the Transfer of Functions (Factories, &c., Acts) Order, 1946 (b), and of all other powers him enabling, hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Employment of Young Persons (Glass Containers) Regulations, 1955, and shall come into operation on the first day of March 1955.

(2) The Interpretation Act, 1889 (c). applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

Application of Regulations

2. These Regulations shall apply to factories in which glass bottles or glass jars are manufactured by automatic or semi-automatic machines as respects male young persons who have attained the age of sixteen employed in a system of four shifts being a system in which the turns worked by each shift do not exceed eight hours in the case of each turn and in which the hours of work of any such young person do not exceed one-hundred and sixty-eight in any period of twentyeight consecutive days.

Modification of the conditions in Section 81 (2) of the Act

3. As respects young persons to whom these Regulations apply, the conditions contained in sub-section (2) of Section 81 of the Act shall be modified by the substitution of the following for paragraph (c) of the said sub-section (2), that is to say:

"(c) no such young person shall be employed between twelve midnight and six o'clock in the morning on more than twelve days in any period of twenty-eight consecutive days:

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations, which apply to certain factories in which glass containers are manufactured, modify the conditions in sub-section (2) of Section 81 of the Factories Act, 1937, so as to enable male young persons who have attained the age of 16 to be employed in consecutive weeks between twelve midnight and six o'clock in the morning provided they are not employed during those hours on more than twelve days in any period of twenty-eight consecutive days.

REGULATIONS FOR THE RECRUITMENT OF LEGAL ASSISTANTS IN GOVERNMENT DEPARTMENTS IN SCOTLAND.

1. Age.

Candidates must be at least 26 and under 40 years of age on 1st February 1955. But a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may for this purpose deduct the period of such service from his actual age.

2. Sex and Marriage

(i) Both men and women may compete under these Regulations.

lations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total phy ical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marri ge gr turty paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished ervice immediately fo lowing the period in re pect of which the gratuity was paid) and the date of re-establishment is more than seven years. than seven years.

3. Nationality

C ndidates must be British subjects. They must also sati fy one of the following conditions:

(a) If natural-born British subjects, they must either: --(i) have at lea t one parent who is or was at death a British subject; or

(ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at leaste five years out of the last eight years preceding the date of their appointment.

(b) If naturalised Bri ish subjects, they must have resided in Her Majesty's dominions and /or been employed elsewhere in the servi e of the Crown for at lea t five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualifications.

Candidates must on the closing date for the receipt of

applications be advocates or qualified solicitors in Scotland. Experience at the bar or in a solicitor's office, will be an advantage.

5. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

6. Competition.

The Commissioners may summon to appear before a Se ection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualificaor may, if they see fit, summon only those whose qualifica-tons and experience are considered to be most suitable. The Se ection Board will take into consideration the candi-dates' record of experience and education, any recommenda-tion from persons named by the candidates as having direct knowledge of their work, and the personal qu lities of the candidates as shown at the interview; and on their estima-tion of all the above facts they will frame their recommenda-tions. The decision of the Commissioners will be final.

7. Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the con ent of the appropriate central education authority (e.g., the Scottish Education Department, the Ministry of Educa-tion, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

8. Ass'gnment.

The Commissioners will decide to which Department The Commissioners will decide to which Department each successful candidate is to be assigned. A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment. Assignments will be made in accordance with the needs of the public service, but the wishes of candidates will, where possible, be taken into account.

9. Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

10. Fee.

Every successful candidate will be required to pay a fee of £4 before the issue of a certificate of qualification for appointment.
